SECOND ALLOTMENT TO B.PHARM (LE) COURSE 2022
FACILITY FOR ONLINE OPTION CONFIRMATION

The second phase of the Centralised Allotment Process for admission to the B. Pharm (LE) Course in the Government Pharmacy Colleges and Private Self-financing Pharmacy Colleges of the State for the year 2022-23 commences on **27.03.2023 (Monday)**.

Candidates who have already received an allotment in various Pharmacy Colleges and those who have not received any allotment through the first phase of allotment can confirm online options to be considered for the second phase of online allotment.

Candidates who want to participate in this phase of allotment must confirm their existing options by clicking the '**confirm**' button available on their home page. After online option confirmation, such candidates can delete the unwanted higher options and can rearrange their existing higher options.

The facility for online option confirmation/deletion/rearrangement will be available on the website **www.cee.kerala.gov.in** from **27.03.2023 to 29.03.2023, 11.00 AM**. Those who do not confirm their options online within the stipulated time will not be considered for this phase of allotment.

Candidate may enter their Application Number & password in the link '**B . Pharm (LE)2022-Candidate Portal**' provided in the above website to log on to their home page. Then, by clicking the menu item 'Option Registration', candidates can register their options online. The Provisional allotment based on the online options received up to **11.00 AM on 29.03.2023**, will be published on **30.03.2023** and the final allotment will be published on **31.03.2023**.

SC/ST/OEC/Children of Fisherman/inmates of SriChithra Home, Nirbhaya Home and Juvenile Home candidates are exempted from payment of fees. Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.
