SECOND ALLOTMENT TO B.PHARM (LE) COURSE 2023
FACILITY FOR ONLINE OPTION CONFIRMATION

The second phase Centralised Allotment Process for admission to B.Pharm (LE) Course in the Government Pharmacy Colleges and Private Self-financing Pharmacy Colleges of the State for the year 2023-24 commences on **16.03.2024 (Saturday)**.

Candidates who are having valid options and who are willing to participate in the second allotment have to log in to his/her Home page and confirm their options by clicking the “**Confirm**” button available in the menu ‘**Option Registration**’. Candidates can delete their unwanted options or rearrange their priority for existing options. If a candidate who does not confirm the higher order options by clicking the 'Confirm' button available in his/her Home page, his/her higher order options will not be available in second phase. However, is/her, existing allotment shall be retained.

The facility for online option confirmation/deletion/rearrangement will be available on the website www.cee.kerala.gov.in from **16.03.2024 to 18.03.2024, 5.00 PM**. **Those who do not confirm their options online within the stipulated time will not be considered for this phase allotment.** The Provisional allotment based on the online options received up to **5.00 PM on 18.03.2024**, will be published on **20.03.2024** and the final allotment will be published on **21.03.2024**.

The annual tuition fees in self-financing pharmacy colleges is provisional and will be subject to be final decision of Government/AFRC. The annual tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission. SC/ST/OEC/Children of Fisherman/inmates of Sri Chithra Home, Nirbhaya Home and Juvenile Home candidates are exempted from payment of fees. Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.
