ADMISSION TO B.PHARM (LATERAL ENTRY) COURSE-2025
STRAY VACANCY ALLOTMENT - OPTIONS INVITED

The stray vacancy allotment to B.Pharm (Lateral Entry) Course-2025 is notified to be commenced as per the schedule attached below. In this phase, fresh option registration facility is available to candidates. The vacant seats are published on the website of the Commissioner for Entrance Examinations. Candidates shall register options to any seats they wish to join if allotted, irrespective of the vacancy status notified as any vacancy that may arise during the counselling will also be filled based on these options. As applicable category conversions of seats will take place in the stray vacancy allotment, while registering options for the stray vacancy allotment candidates are advised to take into account those probable vacancies that may arise due to the applicable category conversions, if any .

General Rules of Stray Vacancy Allotment:

Based on the following conditions, Candidates who have figured in the rank list of B.Pharm (L.E)-2025 published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria given in the Prospectus can register fresh options and participate in this phase of allotment.

1. Those who have already been admitted will not be eligible to participate in this phase and subsequent phases of allotments.

2. Those who have got allotment in third phase allotment will not be eligible to participate in this phase and subsequent phases of allotments.
3. Probable vacancies due to category conversions will also be filled up in the stray vacancy allotment based on the options in this stray vacancy allotment, hence candidates are advised to take into account probable vacancies also.
4. The seats received through stray vacancy allotment cannot be changed further at any instance.
5. Candidates who are allotted a seat in the stray vacancy allotment (irrespective of the admission status) will not be eligible for any subsequent allotments.

Option Registration Fee:

Those candidates who wish to register options will have to remit registration fee of Rs.2,000/- (Rupees Two Thousand Only) to the Commissioner for Entrance Examinations. The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent on allotments.

Exceptions in payment of registration fees

1. Candidates who paid the registration fee in previous allotment phases but do not get allotment up to third phase allotment are exempt from further payment.
2. Those candidates who paid the option registration fee in the third phase allotment but were not allotted a seat do not have to pay the option registration fee again in this round.

Candidates belonging to SC/ST/OEC category and those having benefits as per G.O.(Ms) No.25/2005/SCSTDD Dated 20.06.2005 and G.O (Ms)No. 10/2014/BCDD Dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chithra Home will have to remit Rs.500/- (Rupees Five Hundred only) as Registration Fee. The Registration Fee of such candidates who take admission in the allotted college/course will be adjusted in the caution deposit. The registration fee of those candidates who do not get allotment will be refunded. The registration Fee of those candidates who do not take admission will be treated as penalty and will not be refunded. Registration Fees can be remitted by way of online payment.
