### **NOTIFICATION**

#### ADMISSION TO DNB (POST DIPLOMA) COURSES-2021 ONLINE APPLICATION SUBMISSION AND OPTION REGISTRATION

Applications are invited for admission to the State quota seats in DNB (Post Diploma) Courses for the academic year 2021-22. As all the State quota seats are earmarked for In-Service (Medical Education Service/ Health Service/ Insurance Medical Service of the Govt. of Kerala) candidates, Applicants should be In-Service candidates of Medical Education Service/ Health Service/ Insurance Medical Service under Govt. of Kerala.Only In-Service candidates qualified in DNB PDCET-2021 Examination conducted by National Board of Examinations, in the specialties for which seats are available under the State quota for DNB (Post Diploma) courses, are eligible to apply and register their options.

#### Eligibility for Admission:

a. Service candidates who have passed MBBS Degree and Final examination leading to the award of Post Graduate Diploma from Indian Universities recognized as per provisions of the NMC Act 2019 and repealed Indian Medical Council Act 1956. The result of final examination for PG Diploma qualification should have been declared on or before 28th February 2021. They should have qualified the DNB -PDCET 2021

b. Nativity: Applicants have to be Indian Citizens of Kerala origin.

c. Age: For the Medical Education Service quota, the upper age limit is 47 yrs as on 23.02.2021.For Health Service Quota and Insurance Medical Service Quota, the upper age limit is 45 years as on 23.02.2021.

Note: For details, refer Clauses 2, 3, 4 of the Information Bulletin for DNB (Post Diploma).

#### **Submission of Application:**

All In-Service candidates seeking admission to the DNB (Post Diploma) Courses 2021 can apply in the Online application form available from 21 .02.2022 to 27.2.2022, 10AM provided in the website <u>www.cee.kerala.gov.in</u> of the Commissioner for Entrance Examinations and then remit the required fee by way of online payment or by way of e-challan available during the submission of online application. Payment through e-challan can be made in cash at any of the Head/Sub Post Offices in Kerala. After remitting the required application fee candidates should upload their photo and signature, and all necessary certificates(see clause 12 of Information Bulletin) as proof of eligibility and various claims.

The printout of the Application Acknowledgement Page along with all necessary service documents (including copies of uploaded documents) should be forwarded to the respective Heads of Departments (DME/DHS/DIMS). There is no need to send printout of the application acknowledgement page or any documents to the Office of the Commissioner for Entrance Examinations.

**Option Registration:** The selection and ordering of options (Speciality and Institution combinations which the candidate would like to join if allotted) should be done by the candidates as part of the Online application procedure. The facility for selection and ordering of the options shall be available at the link **OPTION REGISTRATION**, which will be available after uploading all necessary documents to the online application. The process of online application will be complete only after registration of options.

#### Application Fee:

The **application fee** is ₹1000 and is non-refundable. Payment is made in the payment section of the application by credit card/debit card or netbanking. Alternatively, the e-challan available in the payment section can be downloaded and taken to a Head/Sub post office in Kerala to pay the fee in cash. The additional charges, if any, such as GST, Payment Gateway or Post Office Charges, as the case may be, has to be borne by the applicant. The payment section of the application has all these details.

#### Last Date and Time for the submission of online application:

All candidates seeking admission to the course should submit the online application along with uploaded documents/certificates mentioned in clause 12 of the Information Bulletin for DNB (Post Diploma) Courses and register options before **10.00AM of 27.02.2022**. Defective and incomplete applications will be summarily rejected. No correspondence will be entertained in this regard.

Candidates will not be allowed to include any information in the application form or to submit any certificates/documents after the submission of the online application and the subsequent uploading of documents through the online application portal.

The allotment of seats to candidates will be made by the Commissioner for Entrance Examinations through the Centralized Allotment Process (CAP). Details of the Centralized Allotment Process (CAP) will be published in the official web site **www.cee.kerala.gov.in** of the Commissioner for Entrance Examinations in due course.

#### Mode of selection:

The Commissioner for Entrance Examinations (CEE) will provide the list of applicants qualified in the DNB PDCET-21 to the respective heads of departments through the Director of Medical Education, Kerala. The Head of Department (DME/DHS/DIMS) concerned, upon verification of applications and related documents will prepare rank list (Refer Information bulletin clause 9)according to merit and service of the candidates. The finalized rank lists will be forwarded to the CEE through the Director of Medical Education(Convenor of Post Graduate Selection Committee). The CEE will conduct the Centralized Allotment Process (CAP) based on the finalized rank lists obtained from the DME and the Options selected and ordered by the candidates according to the relative preferences for various Specialties and Institutions.
