# ALLOTMENT TO MEDICAL & ALLIED COURSES (EXCEPT AYUSH COURSES) ONLINE OPTION CONFIRMATION IS MANDATORY

The activities related to the second phase of allotment to MBBS/BDS courses and third phase allotment to Agriculture, Veterinary, Forestry, Fisheries courses will commence on 26.07.2019. In this phase, allotment will be done to the vacant seats existing in MBBS/BDS courses, and Agriculture, Veterinary, Forestry, Fisheries courses. The vacant seats liable to be surrendered from All India Quota to State Quota for MBBS & BDS Courses and the whole MBBS seats in the newly included colleges are also to be allotted in this phase. Candidates who want to be considered for this phase of allotment to Medical & Allied courses (except Ayush courses) shall have to log into their Home Page provided in the website <a href="www.cee.kerala.gov.in">www.cee.kerala.gov.in</a> and confirm their options by clicking the 'Confirm' button available therein. After Online Option Confirmation, candidates can register fresh options to the newly included colleges under MBBS courses and also can re-arrange their existing higher options / delete the unwanted higher options. The Facility for Online Option Confirmation and registration of fresh options/re-arranging the existing higher options/deleting the unwanted higher options will be available in the website <a href="www.cee.kerala.gov.in">www.cee.kerala.gov.in</a> up to 5.00 pm on 29.07.2019 (Monday).

The allotment result on the basis of options received within the stipulated time will be published on 31.07.2019. The candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee (if applicable) payable to the Commissioner for Entrance Examinations in any of the Head Post Offices in Kerala or by way of online payment on any date from 01.08.2019 to 05.08.2019 and should join the course/college allotted before 5.00 pm on 05.08.2019. The list of Post Offices having facility for fee payment is available in the website.

The higher order options of those candidates who have not joined the college allotted in the previous phase of allotment to Medical & Allied courses and those who have discontinued the course after joining have been cancelled in the concerned stream. Also candidates who stand admitted in MBBS/BDS courses under All India Quota, if details provided by the Medical Counselling Committee, shall not be considered for this phase of allotment to MBBS/BDS Courses.

As per IA 95861/2019WP(C) No.380/2019 of Supreme Court of India dated., 12.07.2019 and as per letter no.S3/119/2019-Health, dated, 25.07.2019 the students who get allotment in Private Medical colleges may be required to furnish a bank guarantee.

Online Option Confirmation is mandatory for being considered in this phase of allotment to Medical & Allied courses (except Ayush courses) for both candidates allotted with a course in the previous phase and those who have not received any allotment in the previous phase. Those who do not confirm their options online will not be considered for the allotment to Medical & Allied courses(except Ayush courses). The existing allotment of those candidates who do not perform online option confirmation shall be retained if he/she stands joined in the course/college as per the previous allotment.

Candidates can register fresh options in this phase (if not registered in previous phase) to the following colleges which were not considered for allotment in the first phase of allotment to MBBS courses.

- 1) All candidates included in the Medical rank list published by CEE can give option to the above newly included colleges.
- 2) Candidates included in the NRI/ community list published by CEE alone can give option to the community/NRI quota seats of above colleges.
- 3) Candidates are advised to file/retain options to the courses/colleges to which they are sure to join and continue studies if allotted, at the time of registration of options.
- 4) The candidates whose results in the respective rank lists have been withheld due to various reasons can also register their online options for allotment. But the options submitted by such candidates will not be considered for allotment unless they produce the required documents to clear the defects and release their ranks before 1.00 pm on 29.07.2019.

#### Token Deposit:

Candidates getting allotment afresh who belong to SC/ST/OEC/Children of Registered Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have no token deposit to the Commissioner for Entrance Examinations and should join the college allotted within the stipulated time.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies, Affiliation from the Universities and Government Orders.

Vacant seats, if any, under MBBS/BDS courses remaining after 05.08.2019 will be filled up through a Mop-up Counselling scheduled to be conducted on 07<sup>th</sup> & 08<sup>th</sup> of August 2019 by the Commissioner for Entrance Examinations. The detailed notification relating to Mop-up Counselling will be published later.
