ORDER

The Hon'ble Supreme Court in its interim order dated 10.05.2019 in WP(c) No. 380/2019 filed by Kerala Private Medical College Managements Association & another read (2)above directed the respondents to open the facility of online submission of applications for Admission to MBBS course in Private unaided Medical Colleges in Kerala irrespective of their domicile. Accordingly, Government as per the letter read as 3rd paper above have given instructions to Commissioner for Entrance Examinations to comply with the Supreme Court directions in this matter.Subsequently, as per the letter read as 4th paper above, the Commissioner for Entrance Examinations has requested the Government to issue appropriate guidelines for the allotment/admission of Non Keralite -II students and also requested to clarify whether admission may be granted to students who come under category of Non-Keralite students-II, outside Kerala in NRI Quota seats.

2. Government after having examined the matter in detail are pleased to earmark 15% seats for the admission of students to UG Courses in Self Financing Medical Colleges in Kerala irrespective of their domicile through All India Entrance excluding NRI Quota.
