The final Mop-up allotment for admission to B.Arch course in Private Self Financing Architecture colleges 2022 is published in the website www.cee.kerala.gov.in.

The allotment is prepared on the basis of the options registered by the candidates during the first mop up allotment. Those candidates who have got an allotment in this phase should join the colleges concerned from 29.10.2022 to 30.10.2022, 5.00 PM. The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in the Allotment Memo. Candidates should take a printout of the Allotment Memo from the Home Page. The Allotment Memo available in this phase will not be available later. Hence, candidates shall have to keep copy of the Allotment Memo for future reference. Candidates who have an allotment can download the Data Sheet containing the basic details of the candidates by clicking the menu item **'Data Sheet'** in the home page. The print of Allotment Memo and Data Sheet along with the documents in Prospectus clause 11.7.1 (as applicable) are to be produced before the college authorities at the time of admission.

Candidates who receive an allotment in this phase should remit the fees to be paid to the Commissioner for Entrance Examinations (if applicable) as specified in the Allotment Memo at any of the Head Post Offices in Kerala or by way of Online Payment on any date from 29.10.2022 to 30.10.2022, 4.00 PM and should join the course/college allotted before 5.00 PM on 30.10.2022. The list of Post Offices having facility for fee payment is available in the website.

Those candidates who do not remit the fee/balance fee (if applicable) and who do not join the course/college allotted within the stipulated time will lose their allotment. The registration fee of those candidates who do not join the allotted college/course with in the stipulated time after getting an allotment and those candidates who quit seats after takings admission through mop up allotment will be considered as Penalty and will not be refunded. Candidates are required to contact the allotted colleges for information regarding joining.

Those candidates, who got admission in Private Self Financing Architecture colleges through previous allotments and got allotment in the Mop Up phase as per new options, must join the newly allotted colleges. Their admissions received through earlier allotment in Private Self Financing Architecture colleges have been cancelled.
