The allotment list to fill up the vacancies existing in Ayurveda, Homoeo, Siddha, Unani & Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses(under KAU) in Government /Self-financing colleges for the academic year 2022-23 has been published on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment list has been finalized after addressing the valid complaints received from candidates against the provisional stray vacancy allotment list published on 24/01/2023. The allotment list has been published on the basis of the online options registered by the candidates during Mop up allotment to the Ayurveda, Homoeo, Siddha, Unani & Medical Allied Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses in Mop up allotment. Candidates admitted to Ayurveda, Homoeo, Siddha, Unani & Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses through the All India allotment or the allotment conducted by the Commissioner for Entrance Examinations, and those candidates who got an allotment in Ayurveda, Homoeo, Siddha, Unani & Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses through the Mop up allotment will not be considered for the Stray Vacancy allotment.

Those candidates who get an allotment should take a printout of the Allotment Memo from their Home Page. The details of allotment such as

**Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details** etc. will be available in the Allotment Memo.

Candidates who receive an allotment through the Stray Vacancy allotment should remit the fees/balance fee (if applicable) as specified in the allotment memo to the allotted colleges and should join the colleges concerned from **27.01.2023 to 30.01.2023, 2.00 PM** with all the required documents mentioned in Prospectus clause 11.7.1.

Candidates allotted under the SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those from Sreechitra home, Juvenile home, Nirbhaya are eligible for fee concession. However, if they are allotted a seat under the minority quota in a self-financing medical college, they must pay the full fee and are not eligible for any fee concession. .

Candidates who get an allotment can download the 'Data Sheet' which contains the basic details of the candidates by clicking the menu item '**Data Sheet**' available on the home page of the candidate. The printout of the Data Sheet, Allotment Memo are to be produced before the college authorities at the time of admission.

The Mop up registration fee of those candidates who do not join the Ayurveda, Homoeo, Siddha, Unani & Medical Allied Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses within the stipulated time after getting an allotment through the Stray Vacancy allotment and of those candidates who lapse the seats after joining the course, will be considered as penalty and will not be refunded. The allotted candidates will not be considered for further allotments. Penalty will also be applicable to those candidates, who lapse the Ayurveda, Homoeo, Siddha, Unani & Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/

Climate change & Environmental Science/B.Tech Biotechnology courses seats through Stray Vacancy allotment, as per KEAM 2022 Prospectus clause 12.2.4 (c)(ii).

Vacancy if any exists in Ayurveda, Homoeo, Siddha, Unani & Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses after **30.01.2023** will be filled through the second phase of stray vacancy allotment. The details of the second phase of stray vacancy allotment will be published later.
