SECOND PHASE FINAL ALLOTMENT PUBLISHED

The Second phase centralised final allotment to the Kerala Ayurveda/ Homoeopathy/Siddha/Unani/Pharmacy/Agriculture/Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses (Under Kerala Agricultural University) to the State quota seats in Government and Private Self financing colleges in the state of Kerala for the academic year 2023-24 is published in the website of Commissioner for Entrance Examinations www.cee.kerala.gov.in. The allotment has been published after addressing the valid complaints received from candidates within the stipulated time, against the Provisional Allotment List published on 07.10.2023. As per the AACCC directives, those candidates who secured All India Quota seats through round 1 and 2 for admission to BAMS, BSMS, BUMS and BHMS courses have been excluded from this allotment to the respective courses.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in the Allotment Memo.

The candidates should take a printout of the allotment memo from the Home Page. The allotted candidates can download the '**Data Sheet**' containing the basic details of the candidates by clicking the menu '**Data Sheet**' available in the home page of the candidates. The printout of this Data Sheet, allotment memo and the documents as per clause 11.7.1 should be produced before the college authorities at the time of admission.

Candidates who have received an allotment should remit the fees shown in the allotment memo to the allotted college itself and should join the course/college allotted from **10.10.2023 to 12.10.2023, 4.00 PM**.

Candidates allotted under SC/ST/OEC category, Children of Fisherman,

and those communities eligible for educational concession as is given to OEC having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra Home, Juvenile Home, Nirbhaya Home, need not pay the tuition fee at the time of admission.

As the fee for 2023-24 academic year is not yet fixed in Self Financing colleges, those candidates who got allotment in Self Financing colleges should provisionally pay the fee fixed for 2022-23 academic year and they have to pay the balance fees in case if the fee to be fixed by the Admission Supervisory Committee/Government/Hon'ble High Court for the academic year 2023-24 is going to be higher than that of 2022-23 for these colleges.

The vacancies that may arise after the second phase allotment to Ayurveda/Homoeo/Siddha /Unani/Pharmacy/Medical Allied courses will be filled up through third round allotment. The schedule of third round allotment will be published later.

Note: Those candidates who do not join the college allotted within the stipulated time (including candidates eligible for fee concession) will lose their allotment .
