ORDER

As per Government Order read above, Government has executed the agreement with KMCT Institute of Emerging Technology and management, Kozhikode and publish the major clauses of the agreement with regard to the fee structure and allotment of seats.

2. Vide letter read as 2nd paper above, the Management has informed a correction in the seat allocation for the Computer Science and Engineering program was on a 50:50 basis (60 seats each) and in the order it is mentioned as 75 seats and have requested to modify the order.

3. Government have examined the matter in detail and are decided to modified the para No. 9 in the Government Order read above as follows:

9. The fee structure applicable to the seat under the categories mentioned below in the college, shall be as given below and this annual fees shall be the same for all the four years of study for the student admitted in 2024-25.

4. In the event of seats being partially filled up by the Commissioner for Entrance Examination, Student admitted to half of the seats allotted by the Commissioner for Entrance Examination, will pay tuition fee and special fee as per Government College fee only

and the other half will pay Tuition fee Rs. 99,000/- (Rupees Ninety Nine Thousand only) and special fee of Rs.25,000/- (Rupees Twenty Five thousand only). Out of the students opting to an Institution, students admitted under SC/ST/OEC and students identified for fee concession under lower income group based on the lower annual family income shall be included in the lower fee category.
