OPTIONS REGISTRATION FOR THIRD PHASE ALLOTMENT TO ENGINEERING/PHARMACY AND OPTIONS CONFIRMATION FOR SECOND PHASE ALLOTMENT TO ARCHITECTURE COURSES-2024 FACILITIES_AVAILABLE

activities third phase The related the to allotment to Engineering/Pharmacy Courses and second phase allotment to Architecture Course began on 22.08.2024. This phase of allotment will be the last phase allotment for Engineering Courses for this year made by the Commissioner for Entrance Examinations to Government/Government Cost Sharing, Autonomous and Private Self Financing Engineering Colleges. The seats remain vacant in Engineering Courses after this allotment will be filled by the Director of Technical Education in the case of Government Colleges and that of other colleges will be filled by the College authorities concerned observing the conditions, rules and regulations contained in the KEAM 2024 Prospectus and Government Orders issued in this regard.

Fresh Online Option Registration for Engineering and Pharmacy Courses

Fresh Online option registration facility is available for

Engineering/Pharmacy courses in the third phase. Eligible candidates included in the Engineering and Pharmacy rank lists published by the Commissioner for Entrance Examinations can register their options through the website www.cee.kerala.gov.in from 22.08.2024 to 26.08.2024, 11.59 PM.

<u>Confirmation and Rearrangement of existing options for Architecture</u> <u>Course</u>

Candidates who want their higher order options in Architecture courses to be considered in this phase of allotment shall have to confirms and re-arrange their higher order options or delete the unwanted options from 22.08.2024 to 26.08.2024, 11.59 PM, through the website www.cee.kerala.gov.in. The options of those candidates who did not take admission in the first phase allotment on or before 24.08.2024 will be cancelled even though they confirm or rearrange options.

On the basis of options received up to **11.59 PM** on **26.08.2024**, the provisional allotment to Engineering/Pharmacy and Architecture courses will be published on **28.08.2024**.

Online option registration/confirmation and rearrangement, as the case may be, is a must for those who got admission and those who got no allotment as per the previous allotments, to consider them in this phase. But those who got an allotment/admission in the previous phases and do not register/confirm and rearrange options for this phase, the admission through the allotment in the previous phase shall be retained.

<u>Those candidates who get allotment in this phase and do not join the</u> <u>college/courses on or before the date prescribed for the same will lose their</u> <u>allotment in the last phase and the allotment in this phase as well as all the</u> <u>options in the stream to which the allotment belongs.</u>

Option Registration Fee:

Those candidates who wish to register options will have to remit registration fee of **Rs.2,000/-** (**Rupees Two Thousand Only**) to the Commissioner for Entrance Examinations. The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent on allotments. Candidates belonging to SC/ST/OEC category and those having benefits as per G.O.(Ms) No.25/2005/SCSTDD Dated 20.06.2005 and G.O.(Ms)No.10/2014/BCDD Dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chitra Home will have to remit **Rs.500** /- (**Rupees Five Hundred only**) as Registration Fee. The Registration Fee of such candidates who take admission in the allotted college/course will be adjusted in the caution deposit. The registration fee of those candidates who do not get allotment will be refunded. The Registration Fee of those candidates who do not take admission will be treated as penalty and will not be refunded.

Registration Fees can be remitted at any of the Head Post Offices in Kerala or by way of online payment. The list of Post Offices is available in the website.
