ENGINEERING/PHARMACY COURSES – DATE EXTENDED &
FACILITY AVAILABLE FOR THIRD PHASE OPTION
REGISTRATION TO ARCHITECTURE COURSE

In continuation to this office notifications dated 22.08.2024 and 24.08.2024 it is further notified that the last date for third phase option registration for Engineering/Pharmacy Courses through the website www.cee.kerala.gov.in is extended up to **02.09.2024, 06.00 PM**. Candidates are required to go through the notification dated 22.08.2024 and 24.08.2024 published in the website www.cee.kerala.gov.in. for more details regarding third phase option registration for Engineering and Pharmacy courses and should ensure that the steps detailed there in are adhered to.

THIRD PHASE OPTION REGISTRATION TO ARCHITECTURE
COURSE IS MANDATORY

The activities related to the third phase allotment to Architecture Course has started. Fresh Online option registration facility is available for Architecture Course in the third phase. Eligible candidates included in the Architecture rank list published by the Commissioner for Entrance Examinations shall register their options through the website www.cee.kerala.gov.in till **02.09.2024, 06.00 PM**. On the basis of options received up to **06.00 PM** on **02.09.2024**, the provisional allotment to Architecture courses will be published on **04.09.2024**.

Option registered for Architecture course by the candidates in the first phase has been cancelled. Therefore, online option registration is mandatory for both those who have received admission and those who did not receive an allotment in the previous phases, in order to be considered for this phase."

But those who received an allotment/admission in previous phases and do not register options for this phase will retain their admission from the previous phase.

Those candidates who get allotment in this phase and do not join the college on or before the date prescribed for the same will lose their allotment as well as all the options in the stream to which the allotment belongs.

Option Registration Fee:

Those candidates who wish to register options for Architecture course will have to remit registration fee of **Rs.2,000/- (Rupees Two Thousand Only)** to the Commissioner for Entrance Examinations. **Candidates who have already paid option registration fee for MBBS/BDS (first phase)/Engineering/Pharmacy (Third phase) need not pay the fee for Architecture course.** The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent on allotments. Candidates belonging to SC/ST/OEC category and those having benefits as per G.O.(Ms) No.25/2005/SCSTDD Dated 20.06.2005 and G.O. (Ms)No.10/2014/BCDD Dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chitra Home will have to remit **Rs.500 /- (Rupees Five Hundred only)** as Registration Fee. The Registration Fee of such candidates who take admission in the allotted college will be adjusted in the caution deposit. The registration fee of those candidates who do not get allotment will be refunded. The Registration Fee of those candidates who do not take admission will be treated as penalty and will not be refunded.

Registration Fees can be remitted at any of the Head Post Offices in Kerala or by way of online payment. The list of Post Offices is available in the website.

2. Candidates who wish to be considered for Engineering/Architecture/Pharmacy courses shall have to ensure that the options registered are arranged in the order of priority intend.
