## <u>KEAM-2024</u> <u>ADMISSION TO MBBS/BDS COURSES</u> <u>SECOND PHASE CENTRALISED ALLOTMENT PUBLISHED</u>

The second phase of allotment to MBBS/BDS Courses-2024 is published on the website of Commissioner for Entrance Examinations **www.cee.kerala.gov.in**. The allotment is based on the online option confirmation made by the candidates up to 12.00 PM on 24.09.2024 through the above website. The allotment has been published after addressing the valid complaints received from candidates against the Provisional Allotment List published on 26.09.2024.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations, if any, as specified in the allotment memo at any of the Head Post Offices in Kerala or by way of Online Payment on any date from 28.09.2024 to 05.10.2024, 3.00 PM and should join the course/college allotted from 30.09.2024 to 05.10.2024, 4.00 PM with all documents mentioned in the allotment memo and as per prospectus clause 11.7.1. The list of Post Offices having facility for fee payment is available in the website.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O.(MS)25/2005/SCSTDD, dated: 20.06.2005 and

G.O.(MS)10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home need not pay token fee to the Commissioner for Entrance Examinations. However if they are allotted seat under Minority/NRI quota seats in Self-financing Medical/Dental colleges they will have to remit the fee as shown in the allotment memo and they will not be eligible for fee concession.

Candidates who have an allotment can download the **'Data Sheet'** containing the basic details of the candidates by clicking the menu item **'Data Sheet'** available in the home page of the candidate. The printout of this Data Sheet is to be produced before the college authorities at the time of admission.

All the allotted candidates should join the course/college as per the allotment before **4.00 PM on 05.10.2024.** Those candidates who do not join the course/college allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.

Those NRI candidates, who have uploaded sworn affidavit from the Sponsor have to clear the defects on or before the last date fixed by the Commissioner for Entrance Examinations for option confirmation to the third phase allotment to MBBS/BDS courses by uploading valid visa/acknowledgement. Those candidates who fail to upload the document as specified within the time limit fixed by the Commissioner for Entrance Examinations will lose the allotment, if any, received under NRI quota in this phase and the Provisional NRI quota claim of the candidate will also stand cancelled. Any allotment received in NRI quota by such candidates in this phase will be treated as provisional. Also the category claims of those candidates who have been provisionally allotted as per interim court orders or due to pending verification of KIRTADS are subjected to final judgment of honorable court /final verification result of KIRTADS.

The schedule of third phase of the Centralised allotment process to MBBS/BDS courses will be published later.

**Note:** <u>Those candidates who do not join the college allotted within the</u> <u>stipulated time will lose their allotment as well as all the existing higher</u> <u>options in the stream to which the allotment belongs</u>. <u>The registration fee</u> <u>of those candidates who do not join within the stipulated time after</u> <u>getting the allotment and those candidates who quit the seats after taking</u> <u>admission will be considered as penalty and will not be refunded</u>.
