**ADMISSION TO AYURVEDA/HOMOEEO/SIDDHA/UNANI/
/MEDICAL ALLIED COURSES-2024
THIRD PHASE FINAL ALLOTMENT PUBLISHED**

The third phase centralised final allotment to the Kerala Ayurveda/ Homoeopathy /Siddha/Unani/ Agriculture/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses (Under Kerala Agricultural University) to the State quota seats in Government and Private Self financing colleges in the state of Kerala for the academic year 2024-25 is published in the website of the Commissioner for Entrance Examinations **www.cee.kerala.gov.in**. The allotment has been published after addressing the valid complaints received from candidates within the stipulated time against the Provisional Allotment List published on 24.10.2024. Those candidates who got allotment/admission to AYUSH courses through AACCC Counselling have been excluded from the State Third Round Allotment. The allotment to BVSC & AH courses is not done during this phase as per direction issued by Veterinary Council of India vide letter no: 6(16) 2021/VCI/811 dated 19/09/2024.

The candidates should take a printout of the allotment memo from the Home Page. The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in

the Allotment Memo. The allotted candidates can download the '**Data Sheet**' containing the basic details of the candidates by clicking the menu '**Data Sheet**' available in the home page of the candidates. The printout of this Data Sheet, allotment memo and the documents as per clause 11.7.1 should be produced before the college authorities at the time of admission. Candidates who have received an allotment should remit the fees shown in the allotment memo and should join the course/college allotted before **28.10.2024, 4.00 PM**.

Candidates allotted under SC/ST/OEC category, Children of Fisherman, and those communities eligible for educational concession as is given to OEC having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra Home, Juvenile Home, Nirbhaya Home, need not pay the tuition fee at the time of admission. However, if such candidates are allotted under Management quota seats in Self-Financing Ayush colleges, they will have to remit the fee as shown in the allotment memo and they will not be eligible for any fee concession.

As the fee for 2024-25 academic year is not yet fixed in Self Financing colleges, those candidates who got allotment in Self Financing colleges should provisionally pay the fee fixed for 2023-24 academic year and they have to pay the balance fees in case if the fee to be fixed by the Admission Supervisory Committee/Government/Hon'ble High Court for the academic year 2024-25 is going to be higher than that of 2023-24 for these colleges. The fees for the management seats in Self-Financing Ayush courses for the academic year 2024-25 is subject to approval of Admission Supervisory Committee/Government.

The vacancies that may be arise after the third phase allotment to Ayurveda/Homoeo/Siddha /Unani/ Medical Allied courses will be filled up through stray vacancy filling. The schedule of stray vacancy filling will be

published later.

Note: Those candidates who do not join the college allotted within the stipulated time (including candidates eligible for fee concession) will lose their allotment. Liquidated damages will also be applicable as per prospectus clause 12.2.4.

Prospectus and Government Orders regarding allotment process will be available in the website **www.cee.kerala.gov.in**. All candidates should frequently visit the above website for information regarding allotment and notifications.
