**THIRD ROUND STRAY VACANCY ALLOTMENT PUBLISHED**

The Third Round Stray Vacancy allotment to Medical & Medical Allied Courses for the year 2024 is published on the website of Commissioner for Entrance Examinations [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

The allotted candidates can take printout of the allotment memo from the candidate portal. The details of allotment of a candidate such as **Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc.**, are available on the home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment should remit the fees as shown in the allotment memo to the allotted college and should join the course/ College allotted before **09.12.2024, 4.00 PM**. Candidates allotted under SC/ST/OEC/ Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home need not pay the tuition fee. **However, if they are allotted under Management seats in Self- financing colleges, they will have to remit the fee as shown in the allotment memo and they will not be eligible for any fee concession.**

Candidates who have an allotment can download the '**Data Sheet**' containing the basic details of the candidates by clicking the menu '**Data Sheet**' available in the home page of the candidate. The printout of this Data

Sheet is to be produced before the college authorities at the time of admission.

Those candidates who have an allotment should join the course/college as per the allotment before **4.00 PM on 09.12.2024** . Those candidates who do not join the course/college allotted within the stipulated time will lose their allotment and the registration fee of such candidates will not be refunded and will be penalized as per KEAM Prospectus clause 12.2.4. Those candidates, who quit seats after taking admission either through stray vacancy allotment or through previous allotments conducted by Commissioner for Entrance Examinations, will be penalized as per KEAM Prospectus clause 12.2.4.

Vacancies, if any, existing in Ayurveda/Homoeo/Sidha/Unani and Medical Allied Courses after this stray vacancy filling will be filled through Fourth Phase Stray Vacancy Filling. Those candidates who do not join after getting an allotment through this allotment and those who quit the seats after joining the college will not be considered for Fourth Phase Stray Vacancy Filling. Candidates who joined the allotted seat in this phase are also not eligible for participating in the Fourth Stray Vacancy Allotment. The category claims of those candidates who have been provisionally allotted due to pending verification of KIRTADS/Screening Committee are subjected to final verification result of KIRTADS/Screening Committee.
