ORDER

As per the Prospectus for admission to Medical Courses (KEAM) , one seat is reserved under the Nurses-Allopathy Quota (NQ) for MBBS course for Nurses (Allopathy) in regular service under Government of Kerala in the order of priority, a) Nursing Officer with B.Sc Nursing qualification, b) Nursing Officer with General Nursing and Midwifery qualification, c) Junior Public Health Nurse.

2) Representations have been received in Government to conduct the allotment under Nurses-Allopathy quota solely based on the rank attained by the eligible Nurses in regular service under Government of Kerala in NEET entrance examinations. It is a matter of concern that due to the order of priority, Nursing Officers with General Nursing and Midwifery qualifications and Junior Public Health Nurses are not being allotted seats under the Nurses-Allopathy quota, even if they secure higher ranks in the NEET entrance examinations.

3) As per the Letter read as 2nd paper above ,the Director of Medical Education has also recommended that admission to the MBBS course under the Nurse-Allopathy Quota (reserved seats for nurses) be granted to the Nursing Officers in regular service under Government of Kerala who secures the highest rank in the NEET entrance examination.

4) Government have examined the matter in detail and are pleased to

order that the Nursing Officer in regular service under Government of Kerala who has secured highest rank in the NEET UG conducted by the National Testing Agency (NTA) will be eligible for admission to MBBS course under Nurse-Allopathy Quota from the current academic year onwards.
