In continuation of the GOs read above, Government are pleased to notify the fee structure of M.B.B.S course for the academic year 2024-25,2025-26 & 2026-2027 and MD/MS courses for the academic year 2024-25 in P K Das Institute of Medical Sciences ,Vaniyamkulam

Palakkad as fixed by the Fee Regulatory Committee for Medical Education in Kerala as follows;

I) M.B.B.S Fee Structure for 2024-2025 ,2025-26 & 2026-2027

II) MD /MS Fee structure for 2024-2025

1	Tuition Fee for PG Clinical Course - 85% - Merit Quota	₹18,49,748/-
2	Tuition Fee for PG Non-Clinical Course - 85% Merit Quota	₹11,23,062/-
3.	Tuition Fee for PG Medical Courses -15% NRI Quota	₹38,86,680/-

2) The tuition fee, special fee and other eligible fees in respect of SC/ST/OEC students admitted for the course will be sanctioned to the college by the Director of SC/ST Development Department at the rates fixed by the Fee Regulatory Committee for Medical Education in Kerala.

3) The fee fixed by the Fee Regulatory Committee as detailed above shall be the fee for the entire five year course for the respective academic year . Any change regarding the ownership of management of the institution during the entire five year course will not affect the fee as fixed by the Fee Regulatory Committee mentioned above .

4) The College shall not charge either directly or indirectly any other amount over and above the amount fixed as tuition fees.

5) Utilization of Rs 5,00,000/- collected from NRI Quota MBBS students shall be as ordered in the Judgment of Hon'ble Supreme Court in SLP(C) No .9885-9888/2020 read as 10th paper above.
