ONLINE SUBMISSION OF MARKS DATA FOR THE PREPARATION OF ARCHITECTURE RANK LIST 2025

The Architecture (B.Arch) Rank list 2025 will be prepared by giving equal weightage to the score obtained by candidates in the National Aptitude Test in Architecture (NATA-2025) conducted by the Council of Architecture and the marks obtained in the Qualifying Examination (Plus Two/Diploma or equivalent). The candidates who have qualified in NATA-2025 and wish to be included in the Architecture Rank list 2025 shall have to submit the total marks obtained in the Plus Two/Diploma or equivalent Qualifying Examination and the NATA-2025 score through the website **www.cee.kerala.gov.in**.

Candidates can enter the home page through '**KEAM 2025-Candidate Portal**' in the above website by giving their Application Number and Password. Then by clicking the Menu '**Mark Submission for B.Arch**', the marks data can be submitted as per the instructions therein. Candidates who have got grades in the qualifying examination should enter equivalent marks. After entry of marks, confirmation has to be done by such candidates by clicking on '**Submit**' button. Then the candidate should upload the **Plus Two/Diploma or equivalent mark sheet and NATA-2025 Score card as pdf files** through the link '**upload NATA Score Card and Plus Two/Diploma or equivalent Mark Sheet**' provided in the web page. The

uploaded documents should be complete, readable and without any defects. After uploading the documents, the candidates should download the **Mark Submission Confirmation Report** through the link '**Print Mark Submission Confirmation Report**' and keep the hard copy or soft copy for future reference. **Confirmation report/mark sheet/ NATA score card should not be sent to the Office of the Commissioner for Entrance Examinations.** The original mark sheets should be produced before the admitting authority at the time of admission for verification. If any variation is noticed in marks, the admission will be cancelled.

Candidates from Boards such as CBSE in which the Board marks are available for only one year need to submit the marks of the second year of plus two/equivalent alone and upload the Mark list along with NATA-2025 score card. Candidates from Boards such as Kerala Higher Secondary/Vocational Higher Secondary in which Board marks are available for both the years should submit the total marks for both the years and upload the respective Mark lists along with NATA-2025 score card. Candidates who have passed Diploma course should submit the total marks of all the semesters and upload Mark lists of all the semesters along with NATA-2025 score card.

If the mark list are in separate pdf files, the pdf files should be merged and uploaded as a single pdf file.

The website will be open upto **05.07.2025, 5.00 PM** for online submission of marks in the Qualifying Examination and NATA-2025 score and for uploading the required documents.

Applicants who do not submit the score obtained in the National Aptitude Test in Architecture (NATA 2025) conducted by the Council of Architecture and the marks obtained in the qualifying examination (Plus Two/Diploma/Equivalent), who do not upload required documents and

who have not qualified in NATA-2025 will not be considered for the preparation of Architecture Rank 2025.

Note

The NATA Brochure 2025 of Council of Architecture says that in case the candidate appears in multiple tests, all the previous scores shall appear on the score card. The best score obtained in all attempts shall be taken as the valid score for NATA 2025. Therefore, those who have written multiple tests (NATA) should be careful to upload the highest score card.
