KERALA ENGINEERING, PHARMACY RANK LISTS -2025 PUBLISHED

The rank lists for admission to Engineering, Pharmacy courses 2025 are published herewith. The rank details will be available in the KEAM 2025 portal on the website of the Commissioner for Entrance Candidate Examinations www.cee.kerala.gov.in.

The Computer Based Entrance Examinations for Engineering, Pharmacy courses were conducted from 23.04.2025 to 29.04.2025. The normalized score obtained by candidates in the Engineering, Pharmacy Entrance Examinations were published on 14.05.2025. Those candidates who have qualified in the Engineering Entrance Examination were directed to submit the marks obtained for Mathematics. **Physics** and Chemistry/Computer Science/Biotechnology/Biology in the Second year of Plus Two or equivalent Qualifying Examination through the website www.cee.kerala.gov.in for the preparation of Engineering Rank list. Out of 76227 candidates qualified in the Engineering Entrance Examination 67505 candidates have submitted their marks in the second year of the Qualifying Examination to the Commissioner for Entrance Examinations.

For the preparation of Engineering Rank list, weightage of 50:50 was given to the normalized score obtained in the Entrance Examination for Engineering and the normalized score obtained for Mathematics, Physics and Chemistry/Computer Science/Biotechnology/Biology put together in the Second year of the Qualifying Examination (Plus Two or equivalent), after effecting the Normalization procedure as described in the G.O.(Ms) CEE/9/2025-TA1 1/348306/2025

No.470/2025/HEDN Dated 01.07.2025.

Rank list for admission to B.Pharm Course is prepared as per conditions stipulated in Clause 9.7.4 (f) of the Prospectus.

The results of some of the candidates in the above Rank lists have been withheld due to the defects in their application or other reasons. The results of such candidates will be released as and when the reasons for withholding their results are cleared.

The inclusion of a candidate in the rank list does not entitle him/her for admission to the courses unless he/she satisfies all the conditions of eligibility as prescribed in the Prospectus. Candidates will be admitted to the courses, only if the academic eligibility conditions as prescribed in the Prospectus under Clause 6.2.2 (Engineering course),6.2.4 (B.Pharm course) are fulfilled at the time of admission. This will be verified by the college authorities concerned, at the time of admission. The marks in the Qualifying Examination reckoned for preparing the Engineering rank list will be final and will be subjected to verification by the admitting authority. In case, any discrepancy is noticed by the admitting authority in the marks submitted for the preparation of Engineering Rank List, the candidature will stand cancelled. The rank list for admission to Architecture course and the category/community-wise lists based on the rank lists will be published in due course.
