## <u>ORDER</u>

As per Government Order read as 1 <sup>st</sup> paper above, Government had issued Prospectus for the KEAM 2025. Further as per Government Order read as 2<sup>nd</sup> paper above, certain amendments were made in the Prospectus for KEAM 2025.

2. The Honorable High Court while considering the Writ petitions filed, challenging the Government Order read as 2<sup>nd</sup> paper above, directed Commissioner for Entrance Examinations to publish the rank list for KEAM 2025, following the conditions in the Prospectus

issued as per Government Order read as first paper above.

3. Government preferred to file Writ Appeals against the direction of the Single Bench. However, the Division Bench of the Honorable High Court has confirmed the orders of the Single Bench and the appeal filed by the government were thus dismissed.

4. In the above circumstances, Government have examined the matter in detail and decided to cancel the Government Order read as  $2^{nd}$  paper above. The Commissioner for Entrance Examinations will make necessary arrangements to publish the KEAM 2025 ranklist as per the conditions laid down in the Government Order read as first paper above. The Judgements of the Honorable High Court read as  $4^{th}$  paper above are thus complied with.
