KEAM-2025 ADMISSION TO AYURVEDA/HOMOEO/SIDDHA/UNANI/ **MEDICAL ALLIED COURSES-2025** THIRD PHASE FINAL ALLOTMENT PUBLISHED

The third phase centralised final allotment to the Kerala Ayurveda/ Homoeopathy /Siddha/Unani/ Agriculture/Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses (Under Kerala Agricultural University) to the State quota seats in Government and Private Self-financing colleges in the state of Kerala for the academic year 2025-26 is published in the website of the Commissioner for Entrance Examinations www.cee.kerala.gov.in. The allotment has been published after addressing the valid complaints received from candidates within the stipulated time against the Provisional Allotment after including resignations for VCI /ICAR quota . Those and candidates who got allotment/admission to AYUSH courses through AACCC Counselling have been excluded from the State Third Round Allotment.

The candidates should take a printout of the allotment memo from the Home Page. The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in the Allotment Memo. The allotted candidates can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu 'Data **Sheet'** available in the home page of the candidates. The printout of this Data Sheet, allotment memo and the documents as per clause 11.7.1 should be produced before the college authorities at the time of admission. CEE/233/2025-TA4 I/456458/2025

Candidates who have received an allotment should remit the fees shown in the allotment memo and should join the course/college allotted **before 30.10.2025, 4.00 PM**.

Candidates allotted under SC/ST/OEC category, Children of Fisherman, and those communities eligible for educational concession as is given to OEC having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra Home, Juvenile Home, Nirbhaya Home, need not pay the tuition fee at the time of admission. However, if such candidates are allotted under Management quota seats, they will have to remit the fee as shown in the allotment memo and they will not be eligible for any fee concession.

The vacancies that may arise after the third phase of allotment to Ayurveda, Homoeopathy, Siddha, Unani, and other Medical Allied courses (except B.V.Sc. & A.H.) will be filled through the stray vacancy filling process. The filling of vacancies in B.V.Sc. & A.H. courses through stray vacancy round will be subject to the VCI cut-off date for admission. The schedule of stray vacancy filling will be published later.

Note: Those candidates who do not join the college allotted within the stipulated time (including candidates eligible for fee concession) will lose their allotment. Liquidated damages will also be applicable as per prospectus clause 12.2.4.
