## **KEAM -2025** ADMISSION TO AYURVEDA, SIDDHA, HOMOEO, UNANI **COURSES IN KERALA** ONLINE FACILITY FOR SUBMISSION OF NEET (UG) -2025 RESULT

The admission to the Ayurveda, Homoeopathy, Siddha, Unani courses are as per the rank list prepared by the Commissioner for Entrance Examinations based on the score of the candidates in NEET-UG 2025. Candidates who have submitted online application to Commissioner for Entrance Examination as per the notification dated 31.10.2025 and appeared in NEET (UG)-2025 and opting for admission to Medical Courses such as Ayurveda, Homoeopathy, Siddha, Unani shall have to submit their NEET (UG) - 2025 result details to the Commissioner for Entrance Examinations for preparing the revised State rank lists. The online facility for submission of NEET (UG) – 2025 result details will be available in the website www.cee.kerala.gov.in till 09.11.2025, 11.59 PM. The above facility is also open to those candidates who have already submitted online applications based on earlier notifications, but stray vacancy option registration for such candidates will be restricted only to AYUSH courses.

Candidates who do not submit their NEET (UG) - 2025 results to the Commissioner for Entrance Examinations within the stipulated time shall not be considered for the preparation of revised rank list for the courses such as Ayurveda, Homoeopathy, Siddha, Unani.

## STEPS FOR SUBMITTING NEET RESULT

• Access the website www.cee.kerala.gov.in

• Click the link **'KEAM 2025-Candidate Portal'** and provide KEAM-2025 Application number and Password to enter the Home Page of the candidate.

- Click the Menu 'NEET Result Submission' and provide NEET (UG)-2025 Roll Number, NEET (UG)-2025 Application Number and NEET (UG)-2025 Date of Birth.
- Verify the score card for NEET (UG)-2025 –Candidate's Name, Name of Father, Name of Mother, NEET (UG) result details shown in the screen with NEET (UG) 2025 NEET Percentile Score, All India Rank for counseling etc.
- If the details are correct, click the 'Verified and Submit' button. (Note:- The procedure of submission of NEET result will be completed only when the 'Verified and Submit' button is clicked).
- Take the printout of 'NEET Result Submission Report' and keep it with the candidate for future use.

Candidates should not send/upload the NEET Score Card or NEET Result Submission Report to the Commissioner for Entrance Examinations. All candidates are requested to go through the Government approved Prospectus for admission to Professional Degree courses-2025, available in the website www.cee.kerala.gov.in.
