ALLOTMENT TO ENGINEERING/ARCHITECTURE/PHARMACY COURSES: **ONLINE OPTION CONFIRMATION STARTED**

The activities related to the third phase of allotment to Engineering, Pharmacy Courses and second phase of allotment to Architecture Course began on **07.11.2020**. In this phase, candidates can register options to the newly included Self-Financing Pharmacy colleges and newly included Civil Engineering Course in Government Engineering College, Palakkad, Computer Science & Engineering (Data science) course in Mar Athanasius College of Engineering, Kothamangalam.

Online Option Confirmation is mandatory for Engineering/ Architecture/ Pharmacy Courses

The Candidates who want their higher order options in Engineering, Pharmacy courses to be considered in the third phase of allotment and Architecture courses in the second phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added Courses/Colleges if applicable, from **07.11.2020 to 09.11.2020, 1.00 pm**, through the website **www.cee.kerala.gov.in**. On the basis of options received up to **01.00 pm** on **09.11.2020**, the third phase allotment to Engineering, and Pharmacy courses and second phase allotment to Architecture course will be published in the evening on **10.11.2020**. Candidates who receive allotment in Engineering, Pharmacy or Architecture Courses in this phase shall have to take a printout of their allotment memo and remit the fee/ balance fee payable (if applicable) to the Commissioner for Entrance Examinations, at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **11.11.2020 to 13.11.2020, 4 pm**. The list of Post Offices having facility for fee payment is available in the website. After remitting the fee/balance fee, the candidates should join the course/college allotted before **4 pm** on **13.11.2020**.

Online option confirmation is a must for those who got admission and those who got no allotment as per the second phase allotment, to consider them in the third phase allotment in the case of Engineering/ Pharmacy courses. But those who do not confirm options after admission, the same shall be retained. Similarly, those who got admission and those who got no allotment as per the first phase allotment for Architecture course, online option confirmation is must for second phase allotment. But those who do not confirm options after admission, the same shall be retained. Online Option Confirmation is mandatory for being considered in this phase of allotment for both candidates admitted with a course in the first phase/second phase respectively and those who have not received any allotment in the first phase/second phase respectively including SC/ST/OEC and other candidates eligible for fee concession.

DETAILED SCHEDULE OF THE ALLOTMENT

07.11.2020	Website opens for Online Option Confirmation and for enabling re-arrangement of higher options/deletion of unwanted options and registration of fresh options to the newly added Courses/Colleges for Engineering, Architecture and Pharmacy Courses
09.11.2020 (01.00 pm)	Time for Online Option Confirmation and re-arrangement/ deletion/ addition of options ends
10.11.2020	Publication of Allotment
11.11.2020 to 13.11.2020, 4 pm	Take admission to the concerned college: Candidates who receive allotment should remit the fee/balance fee as shown in the allotment memo, payable to CEE in any of the Head Post Offices in Kerala or by way of online payment and should report before the college authorities to join the allotted college/course for Engineering, Architecture and Pharmacy Courses
13.11.2020, 5 pm	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) for Engineering/Architecture/Pharmacy courses.

Token Deposit :

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, should pay the caution deposit (Rs.1000/-), if they get allotment in Govt. colleges.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies, Affiliation from the Universities and Government Orders.

1. Candidates who fail to confirm their options online will not be considered for allotment under any circumstances.
 2. This phase of allotment will be the last phase of allotment to Private Self Financing Engineering/Architecture/Pharmacy colleges. The availability of higher options to the students allotted to Private Self Financing Engineering and Architecture/Pharmacy colleges shall be as per the Government orders. Hence all the candidates are instructed to go through and satisfy themselves regarding the conditions in the above Government Orders available in the website.

NOTE: Candidates are advised to file options to the courses/colleges to which they are sure to join and continue studies if allotted, at the time of registration of options.
