MOP UP ALLOTMENT TO MBBS COURSE PUBLISHED

Mop Up counselling allotment to fill up the vacant seats in MBBS course after the 2nd phase of Centralized allotment has been published in the website www.cee.kerala.gov.in. The probability list of candidates including five times the number of existing vacancies was prepared, considering the online options received from the candidates from 12.12.2020 to 16.12.2020, 10.00 am. Those candidates in the probability list who have failed to report at the certificate verification or failed to submit required relevant documents at the time of verification are not considered for allotment. The Mop Up allotment is published on the basis of the guidelines vide notification No. CEE/4600/2019/KEAM-2019/TA3 dated 12.12.2020.

The details of Mop Up allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. are available in the home page of the candidate and also in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive Mop Up allotment afresh should remit the fees (if any) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the Head Post Offices in Kerala or by way of Online Payment on any date from **21.12.2020 to 24.12.2020** and should join the college allotted, before 4 pm on **24.12.2020**.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra home, Juvenile home, Nirbhaya home need not remit token deposit to the Commissioner for Entrance Examinations. However if they are allotted seat under Minority/NRI quota in Self-financing Medical colleges, they will have to remit the token fee prescribed to CEE and they will not be eligible for fee concession, also.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item '**Data Sheet**' available in the home page of the candidate. The printout of this Data Sheet and other required documents are to be produced before the college authorities at the time of admission.

All the candidates who have an allotment should join the college on or before 24.12.2020, 4 pm.

Note: Liquidated damages as stipulated in clause 12.2.4(c)(ii) of the KEAM 2020 Prospectus shall be applicable to those candidates who lapse admission procedure after being allotted to the course, and those candidates who lapse the seats after joining the MBBS course.
