NOTIFICATION

B.Tech (Lateral Entry) Course 2020-21 **Online Mop Up Allotment**

The activities related to the Mop Up Allotment for admission to B.Tech (Lateral Entry) Course in the Engineering Colleges of the State for the year 2020-21 will commence on **24.11.2020 (Tuesday)**. All candidates who have figured in the rank list of B.Tech (Lateral Entry) Course 2020 published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per clause 4 in the Prospectus can participate in the Mop Up allotment. **The present admission of the candidates who have got admitted in the colleges in previous phases of allotments shall be cancelled if they register option in this phase and get allotment.** Candidates can register options to all the courses/colleges to which the candidate wish to join as the newly vacant seats due to transfer of students who have already secured admission, will also be filled in this allotment. Those candidates who have not registered their options within the stipulated time will not be considered for this allotment.

The schedule for the allotment is given below

24.11.2020	Website opens for Option Registration
26.11.2020, 12.00 pm	Time for Option registration ends
27.11.2020	Mop Up Allotment
30.11.2020, 4.00 PM	Last Date for joining the allotted college

Online Option Registration is mandatory in this phase. Candidates who wish to participate in the Mop up Allotment shall have to log on to their home Page provided in the website www.cee.kerala.gov.in by giving their Application Number & Password through the link 'B.Tech. (Lateral Entry) 2020- Candidate Portal'. Then by clicking the Menu item Option Registration, candidate can register their options online from **24.11.2020 to 26.11.2020, 12.00 PM.**

All Diploma/D. Voc candidates irrespective of their branches can register options to Information Technology (IT) and Printing Technology (PT) as per annexure B of the Prospectus for Admission to B. Tech (Lateral Entry) 2020.

The Principals of the institutions concerned should issue TC and release all certificates and other relevant documents of the candidates who obtained allotment through centralized Mop Up allotment. The candidates who get allotment in this phase shall have to join the allotted college with all the original certificates as given in the Allotment memo/previous notification before **30.11.2020, 4.00 pm** after remitting the fee, if any, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or through any Head Post Offices in Kerala. The balance tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for educational concessions as is given to OEC/Candidates eligible for fee concession as per GO(Ms)No.25/2005/SCSTDD dated: 20.06.2005/Children of Fisherman/Inmates of Sri Chithra home, Nirbhaya home & Juvenile home allotted under Government Quota are exempted from payment of fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **5.00 pm on 30.11.2020**.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.

Note: *The vacancies, if any, remaining in B.Tech (Lateral Entry) course in Engineering colleges after 4.00 PM on 30.11.2020 shall be filled up through Spot Admission to be conducted by the Principals concerned before 05.12.2020, 5.00 PM.*
