ADMISSION TO THREE YEAR LLB COURSE- 2022
STRAY VACANCY FILLING

The vacancies existing in Three Year LLB Course in various Govt. and Self Financing Law colleges after Mop up Counselling is published in the website of www.cee.kerala.gov.in. These vacancies will be filled up at the respective colleges based on the Lists forwarded by the Commissioner for Entrance Examinations and in accordance with the Guidelines issued by the Commissioner for Entrance Examinations.

Candidates who have already secured admission through the Centralised Allotment Process/Mop up allotment conducted by the Commissioner for Entrance Examinations are not allowed to participate in the stray vacancy filling allotments. Candidates who have left the seat after Mop up allotment as well as those candidates who did not joined the seat allotted in the Mop up Phase are not allowed to participate in the stray vacancy filling allotment.

Three lists have been prepared for the Stray Vacancy Filling Allotment Process

I : Allotment List – List has been prepared based on options registered by the candidates for Mop up allotment and vacancies available. List excludes candidates allotted to the course through , Mop Up Counseling and candidates admitted to the course through phases up to second of Centralised Allotments conducted by the Commissioner for Entrance Examinations. Candidates figuring in the Allotment list can be admitted by the respective colleges during the reporting period itself if found eligible on verifying the original documents and on fee payment.

II: List of Probable Candidates – Candidates who have registered options in the Mop up Counseling excluding those candidates who were allotted a seat in the mop-up phase irrespective of their joining status, and those candidates who are included in the above Allotment List (List-1 of the lists for Stray Vacancy Filling), are included in this list.

III: Other Eligible candidates List – If vacancies exist even after the candidates included in the first two lists have been considered in accordance with the guidelines and instructions, any candidate satisfying the eligibility conditions mentioned above may be considered for

admitting to the remaining stray vacancies. In addition to the general conditions under which a candidate is not allowed to participate in the stray vacancy filling allotments, the condition that any candidate who take admission through the allotment list (List-1 of the lists for Stray Vacancy Filling) is also not allowed to change the allotment afterwards, is also applicable as far as eligibility for allotment under this clause is concerned.

Reporting Period: Candidates eligible and desirous of admission to the course should report before the concerned college authority with all the documents including TC in original, and the fee to be paid to the college before the end of the reporting period. The reporting period is from 23.12.2022 to 27.12.2022, 2:00 PM, based on which the allotment will be done by the respective colleges and the selection list as well as the waiting list will be prepared. The admission process based on the list should be completed by 4:00PM of 30 .12.2022.

Candidates can view the Lists and the Guidelines published in the official website of the Commissioner for Entrance Examinations. Candidates should submit all the required document as per clause 18 and shall remit the entire fee directly to the college.

Guidelines for the Stray Vacancy Filling Allotment have been published in the official website of the Commissioner for Entrance examinations.
