# ADMISSION TO THREE YEAR LLB COURSE- 2024 SECOND ROUND STRAY VACANCY ALLOTMENT & COLLEGE LEVEL STRAY VACANCY FILLING

The Second Round Stray Vacancy Allotment for admission to Three Year LL.B Course for the academic year 2024-25 in the Government Law Colleges and Private Self Financing Law colleges of the State, is published in the website **www.cee.kerala.gov.in**. Allotment is based on the rank in the rank list of Three Year LLB course published by the Commissioner for Entrance Examinations and online options registered by the candidates for the second phase stray vacancy allotment based on the conditions specified in the notification No. CEE/143/2024-TA3 dated 26.11.2024

Candidates can access their homepage by entering their Application number and Password in the "Three Year LLB 2024- Candidate Portal" provided in the above website. Then by clicking the menu 'Allotment Result', candidates can view their Allotment details and can download their Allotment memo. The details such as candidate's name, roll number, allotment, tuition fees, deposit if any etc., are available in the Allotment Memo. Candidates shall also log into their Home page and click the Menu 'Data Sheet' for downloading the Data Sheet.

Candidates should report for admission before the Principal of the allotted colleges on or before **29.11.2024**, **12.00 PM** along with the allotment memo and original documents specified in Clause 19 of the Prospectus, and should remit the fee as shown in the allotment memo at the concerned college. Candidates should remit the balance fees, if any, as per Government orders in the allotted college at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational

concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on or before 29.11.2024, 1.00 PM.

## Candidates who do not join the college within the stipulated time will lose their present allotment.

**Note:** Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be provisional and subject to final verification of their caste status.

### **COLLEGE LEVEL STRAY VACANCY FILLING**

The vacancies existing after second round stray vacancy allotment in Three Year LLB Course in various Govt. and Self Financing Law colleges will be filled up at the respective colleges based on the lists forwarded by Commissioner for Entrance Examinations and in accordance with the Guidelines issued by Commissioner for Entrance Examinations.

The various lists of candidates for the college level stray vacancy filling after the second phase stray vacancy allotment will be prepared based on the options registered for the second round stray vacancy allotment process. But the options registered in second round stray vacancy allotment by already admitted candidates will not be considered for college level stray vacancy filling rounds.

### The Lists have been issued for college level stray vacancy filling round of admission.

List I: Probable candidates List— Candidates who have registered options for the second phase stray vacancy allotment but didn't get any allotment in the phase are included in the list. These candidates will be considered only to those vacancies existing after second round stray vacancy allotment. Candidates shall be considered from this list based on the priority.

List 2: Eligible candidates List- If vacancies exist after the List I is exhausted, any candidate satisfying the eligibility conditions to participate in stray vacancy filling is to be considered for admitting to the remaining stray vacancies.

### **Reporting Period**

1. Candidates including in the List I should report before the concerned college authority with all the documents including TC in original, and the fee should be paid to the college before the end of reporting period. The reporting period is from 29.11.2024, 12 PM to 29.11.2024, 2.30 PM, based on which the allotment will be done by the College before 4.00PM of 29.11.2024. Candidates shall be considered from these lists based on the priority.

2. Candidates including in the List 2 should report before the concerned college authority with all the documents including TC in original, and the fee should be paid to the college before the end of reporting period. The reporting period is from 30.11.2024, 10 AM to 30.11.2024, 1.00 PM, based on which the allotment will be done by the College before 4.00PM of 30.11.2024. Candidates shall be considered from these lists based on the priority.

Candidates included in the Lists, may contact the college authorities concerned and participate in the allotment process as per the reporting time. Candidates should submit documents as per clause 19 and shall remit the entire fee at the time of reporting.
