ADMISSION TO THREE YEAR LLB - 2025 **SECOND PHASE ALLOTMENT** **ONLINE OPTION CONFIRMATION IS MANDATORY**

The activities related to the second phase of Centralised Allotment for admission to Three Year LL.B Course in the Government and government seat in Private Self-financing Law Colleges of the State for the year 2025-26 commenced in the website **www.cee.kerala.gov.in** on 06.08.2025

Those candidates who have received an allotment and taken admission in the allotted college in the first phase, and want their existing higher order options to be considered for the second phase shall have to compulsorily confirm their online options by clicking the ‘**Confirm**’ button available in their home page provided in the website **www.cee.kerala.gov.in**. The candidate who have exercised options but not allotted to any seats in the first phase should also confirm their options.

After Online Option Confirmation, the candidates can change the priority of existing higher options and delete the unwanted higher options, if desired. The facility for Online Option confirmation/re-arrangement/deletion of options has been made available in the above website. Those who do not confirm their higher options online within the stipulated time will not be included for this phase of allotment. But the present admission, if any, of such candidates during the first phase of allotment shall be retained. The request for option confirmation /re-arrangement/deletion of options received via Post/Fax/e-mail/hand delivery will not be considered under any circumstances.

The following candidates are eligible to participate in the Second Phase

of allotment by clicking the ‘**Confirm**’ button available on the home page of the Candidate Portal.

- Candidates who received an allotment in the first phase and got admitted to the allotted colleges and continued in their admitted status.
- Candidates who have registered options for the first phase, but did not receive any allotment in the first phase, and who want to be considered for the second phase of allotment.
- All eligible candidates can register fresh options to the following college.

The schedule for the allotment is given below :

06.08.2025	Website opens for Option registration/Confirmation/re-arrangement /deletion of options.
09.08.2025, 10.00 AM.	Time ends for Option registration/ Confirmation /re-arrangement/deletion of options.
09.08.2025	Publication of second Phase of Provisional Allotment
11.08.2025	Publication of second Phase of Final Allotment

Candidates who receives allotment should have attained the eligibility for admission as per Clause 9 of the Prospectus at the time of admission.

The candidates who get allotment in this phase shall have to join the allotted college within the stipulated time. (Detailed schedule regarding the joining will be notified later). Candidates who get allotment shall have to pay the amount shown in the allotment memo in the allotted colleges at the time of admission.

Fee Concession:

Candidates belonging to SC/ST/OEC/Communities eligible for educational concessions as is given to OEC/Candidates eligible for fee

concession as per GO(Ms)No.25/2005/SCSTDD dated: 20.06.2005/Children of Fisherman/Inmates of Sri Chitra Home, Nirbhaya home & Juvenile home allotted under Government Quota are exempted from payment of fees.

Important

- 1. Candidates who do not take admission within the specified dates shall lose their allotment.*
- 2. Candidates who receive a change of allotment to their higher options in the second phase of allotment will automatically lose their current admission and they should obtain the T.C and relevant documents from their currently admitted college and join the newly allotted colleges within the specified date notified by the CEE.*
