The candidate who have exercised options but not allotted to any seats in the first phase should also confirm their options.

After Online Option Confirmation, the candidates can change the priority of existing higher options and delete the unwanted higher options, if desired. The facility for Online Option confirmation/re-arrangement/deletion of options has been made available in the above website. Those who do not confirm their higher options online within the stipulated time will not be included for this phase of allotment. But the present admission, if any, of such candidates during the first phase of allotment shall be retained.
