# ADMISSION TO THREE YEAR LLB COURSE-2025 VACANT SEAT FINAL ALLOTMENT PUBLISHED

The Vacant Seat Final Allotment for admission to Three Year LLB course 2025 to fill up vacant seats in the Government and Self Financing Law colleges is published in the website **www.cee.kerala.gov.in**. Vacant Seat Allotment to Three Year LLB Course have been prepared after addressing valid complaints received within stipulated time regarding Provisional Allotment List published on 22.08.2025. Vacant Seat allotment has been prepared on the basis of the conditions stipulated in Three Year LLB Prospectus clause 18.

To view the Allotment Result, candidates should log on to the 'Three Year LLB 2025-Candidate Portal' by submitting their Application Number and Password. By clicking on the link 'Allotment Result', candidates can view their Allotment Result. It is necessary to take the printout of the Allotment Memo. The allotted candidates should join at the allotted colleges from 25.08.2025 to 29.08.2025, 3.00 PM, along with all required documents specified in the Allotment Memo as per Prospectus clause 19.

## **General Rules of Vacant Seat Allotment:**

- 1. If no seat is allotted to the candidate in the vacant seat allotment, the existing admission, if any, shall prevail, and if a seat is allotted to the candidate in the vacant seat allotment, the existing admission, if any, will stand cancelled and the candidate shall have to accept the new allotment.
- 2. The seats received through vacant seat allotment cannot be changed further at any instance.
- 3. Candidates who are allotted a seat in the vacant seat allotment

- (irrespective of the admission status) will not be eligible for any subsequent allotments.
- 4. Allotment shall be subject to the final order/affiliation/approval of the Govt./Bar Council of India/University concerned.
- 5. Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) before **29.08.2025**, **4.00 PM**. Candidates who do not join the college within the stipulated time will lose their present allotment, if any.

### Note:

- 1. Allotment/admission of candidates whose writ petitions are pending disposal in Hon'ble High Court of Kerala is provisional in this phase, and will be finalized on receipt of respective court orders.
- 2. Candidates who do not take admission within the specified dates shall lose their allotment.
- 3. Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by screening committee have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.
