ALLOTMENT TO THREE YEAR LLB COURSE 2024-25 ONLINE OPTIONS INVITED

The Centralised Allotment Process (CAP) for admission to the seats in Three Year LL.B Course in 4 Government Law Colleges and 50% Government seats in 13 Private Self-financing Law Colleges of the State for the year 2024-25 has commenced.

Candidates included in the rank list can register their options online through the website **www.cee.kerala.gov.in** till **26.09.2024.** Candidate may enter their Application Number & Password in the link **'Three Year LL.B 2024 - Candidate Portal'** provided in the above website to log on to their home page. Then by clicking the menu **'Option Registration'** candidates can register their options online. The first allotment will be published based on the online options received upto 3.00 PM on 26.09.2024.

Candidates whose results are withheld due to defect in application can also register online options, but If relevant documents are not uploaded by such candidates before **25.09.2024**, **3.00 PM**, their options will not be considered for the allotment process.

Option Registration Fee:

Those candidates who wish to register options will have to remit registration fees of Rs.1000/- (Rupees One Thousand only) to the Commissioner for Entrance Examinations. Candidates belonging to SC/ST/OEC category eligible for benefits as per G.O (Ms) No. 25/2005/SCSTDD, dated: 20.06.2005 and G.O (Ms) No.10/2014/ BCDD, dated: 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sreechithra Home will have to remit Rs.500/- (Rupees Five Hundred Only) as Registration Fee. Registration fees candidates who do not get allotment will be refunded. If a candidate gets allotment and does not join within the stipulated time, the option registration fee will be considered as penalty and will not be refunded. Option registration fee of those candidates who quit the seats after taking admission will be considered as penalty and will not be refunded. Refund of option

registration fee for the eligible candidates will be made only after the completion of allotment process and it will be notified.

Candidates who fail to register their options online within the stipulated time will not be considered for allotment under any circumstances. Options forwarded to the Commissioner for Entrance Examinations by Email/Post/Hand delivery will not be processed or considered on any account for the allotment of seats.

As the fee for the academic year 2024-25 is not yet fixed, candidates shall pay the fee fixed for the year 2023-24 and will be liable to pay the balance fee, in case, if the fee to be fixed for the academic year 2024-25 is higher than that of 2023-24.

Documents to be produced at the time of admission

- 1. Candidate's Data Sheet.
- 2. Allotment Memo issued by the Commissioner for Entrance Examinations.
- 3. SSLC or any relevant school records/birth certificate/passport/other valid document to prove date of birth in original.
- 4. Original Mark list and Pass Certificate of the qualifying examination.
- 5. Transfer Certificate and Conduct Certificate from the institution where the candidate studied last.
- 6. Four copies of recent passport size photograph.
- 7. The applicant who is employed or trainee in Government/Quasi Government/Banks etc. shall, at the time of interview, produce a relieving order and a certificate of good conduct from the Head of the Institution where the candidate was employed.
- 8. Candidates who passed their qualifying examination from Universities/Boards outside the state shall produce an "Eligibility Certificate" from the concerned University in Kerala, to the effect that the qualifying examination has been recognized by the University.
- 9. The student who qualifies from other Universities should produce migration

certificate at the time of admission or before 1^{st} semester examinations for the course.

- 10. Originals of all the uploaded documents/certificates (to prove nativity /reservation/fee concession).
- 11. Any other certificates/documents required to be furnished as per the prospectus/notifications/allotment memo.

Note:

- 1. The allotment to college/courses will be subject to final orders of recognition of the Bar Council of India, No Objection Certificate from the Government and affiliation from the Universities concerned.
- 2. Candidates are advised not to give unnecessary options to courses/colleges where they do not wish to join, if allotted and to visit the official website of the Commissioner for Entrance Examinations frequently for notifications and latest updates.
