ALLOTMENT TO INTEGRATED FIVE YEAR LL.B COURSE 2021-22
FIRST PHASE OF ALLOTMENT PUBLISHED

The First Phase of Centralized Allotment (CAP) for admission to Integrated Five Year LL.B Course in 4 Government Law Colleges and 19 Private Self-financing Law Colleges of the State for the year 2021-22 is published herewith in the website www.cee.kerala.gov.in . The allotment is based on the online options registered by candidates up to **5.00 Pm on 16.10.2021**.

Candidates can access their homepage by entering their application number, and password in the '**Integrated Five Year LLB 2021-Candidate Portal**' provided in the website. Then by clicking the menu item '**Allotment Result**' candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc. are available in the allotment memo. The candidate shall take a print out of the allotment memo. Candidates can log into their Home Page and then click the Menu Item '**Data Sheet**' for downloading the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges on any date from **20.10.2021 to 25.10.2021, 4 pm** along with the allotment memo and original documents specified in Clause 18 of the Prospectus. They should remit the complete fees as per Government orders in the allotted college at the time of admission. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **25.10.2021, 5.00 pm**.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

The candidates who do not join the college on the specified dates, will lose their present allotment and also the higher order options. Their existing options will not be considered for further allotments, if any. The details regarding further allotments, if any, will be notified later.

Note: Colleges /Additional seats which are not included in the first phase of allotment due to lack of orders from Bar Council Of India, University, Government will be included in the subsequent phases on receipt of required orders.
