ALLOTMENT TO INTEGRATED FIVE YEAR LL.B COURSE 2021-22
SECOND PHASE OF ALLOTMENT PUBLISHED

The Second Phase of Centralised Allotment (CAP) for admission to Integrated Five Year LL.B Course in the 4 Government Law Colleges and Private Self-financing Law Colleges in the State which have entered into seat agreement with Government for the year 2021-22 is published herewith in the website www.cee.kerala.gov.in. The allotment is based on the online options registered by candidates within the stipulated time.

Candidates can access their homepage by entering their Application number, and Password in the 'Integrated Five Year LL.B 2021- Candidate Portal' provided in the above website. Then by clicking the menu item 'Allotment Result', candidates can view their Allotment details. Candidate can download their Allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees, deposit if any etc. are available in the Allotment Memo. Candidates shall have to take a print out of the Allotment Memo. Candidates can also log into their Home page and click the Menu item 'Data Sheet' for downloading the Data Sheet.

Candidates who receive fresh allotment or a change in allotment than in the previous phase shall have to take a print out of the Second phase Allotment memo. Candidates should report for admission before the Principal of the allotted colleges on any date from **08.11.2021 to 11.11.2021, 4.00 pm** along with the allotment memo and original documents specified in Clause 18 of the Prospectus, and should remit the fee as shown in the allotment memo at the concerned college. Candidates should remit the balance fees, if any, as per Government orders in the allotted college at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **11.11.2021, before 5.00 pm**.

Candidates who do not join college within the stipulated time will lose their present allotment and also their higher order options. Also such candidates will not be considered for future online centralized allotments, if any, under Centralized Allotment Process.
