**ALLOTMENT TO INTEGRATED FIVE YEAR LL.B COURSE 2023**  
**ONLINE OPTIONS INVITED**

The Centralised Allotment Process (CAP) for admission to the seats in Integrated Five Year LL.B Course in four Government Law Colleges, and 50% Government seats in 21 Private Self-financing Law Colleges of the State for the year 2023-24 commences on **20.09.2023**.

Candidates included in the rank list can register their options online through the website **www.cee.kerala.gov.in** up to **25.09.2023, 11.00 AM**. Candidate may enter their Application Number & Password in the link '**Integrated Five Year LL.B 2023 - Candidate Portal**' provided in the above website to log on to their home page. Then by clicking the menu '**Option Registration**' candidates can register their options online. The first allotment based on the online options received up to **11.00 AM** on **25.09.2023** will be published provisionally on **26.09.2023** and final allotment will be published on **28.09.2023**.

Candidates whose results are withheld due to defect in application can also register online options, but If relevant documents are not uploaded by such candidates within **23.09.2023, 3.00 PM** their options will not be considered for the allotment process.

**Option Registration Fee:**

Those candidates who wish to register options will have to remit registration fee of Rs.2000/- (Rupees Two Thousand Only) to the Commissioner for Entrance Examinations. The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent on allotments. Candidates belonging to SC/ST/OEC category eligible for benefits as per G.O(Ms)No.25/2005/SCSTDD, dated: 20.06.2005 and G.O(Ms)No.10/2014/BCDD, dated:23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sreechithra Home will have to remit Rs.500/-

(Rupees Five Hundred Only) as Registration Fee. The Registration Fee of such candidates who take admission in the allotted college/course will be adjusted in the caution deposit. The registration fee of those candidates who do not get allotment will be refunded. Bank account details shall have to be provided by the candidates for facilitating refund if any.

Registration fees can be remitted at any of the Head Post Offices in Kerala or by way of online payment. The list of Post Offices is available in the website.

Candidates who fail to register their options online within the stipulated time will not be considered for allotment under any circumstances. **Options forwarded to the Commissioner for Entrance Examinations by Email/Fax/Post/Hand delivery will not be processed or considered on any account for the allotment of seats.**

As the fee for the academic year 2023-24 is not yet fixed, candidates shall pay the fee fixed for the year 2022-23 and will be liable to pay the balance fee, in case, if the fee to be fixed for the academic year 2023-24 is higher than that of 2022-23.

**Documents to be produced at the time of admission**

1. Candidate's Data Sheet.
2. Allotment Memo issued by the Commissioner for Entrance Examinations.
3. SSLC or any relevant school records/birth certificate/passport/other valid document to prove date of birth in original.
4. Original Mark list and Pass Certificate of the qualifying examination.
5. Transfer Certificate and Conduct Certificate from the institution where the candidate studied last.
6. Four copies of recent passport size photograph.
7. The applicant who is employed or trainee in Government/Quasi Government/Banks etc. shall, at the time of interview, produce a relieving order and a certificate of good conduct from the Head of the Institution where the candidate was employed.
8. Candidates who passed their qualifying examination from Universities/Boards outside the state shall produce an "Eligibility Certificate" from the concerned University in Kerala, to the effect that the qualifying examination has been recognized by the University.
9. The student who qualifies from other Universities should produce migration certificate at the time of admission or before 1<sup>st</sup> semester examinations for

the course.

10. Originals of all the uploaded documents/certificates (to prove nativity /reservation/fee concession).
11. Any other certificates/documents required to be furnished as per the prospectus/notifications/allotment memo.
