# ADMISSION TO INTEGRATED FIVE YEAR LL.B COURSE 2025 ONLINE OPTIONS INVITED

The activities related to the Centralised Allotment Process (CAP) for admission to Integrated Five Year LL.B Course in four Government Law Colleges and 50% Government seats in 30 Private Self-financing Law Colleges of the State for the year 2025-26 commences from **21.07.2025**.

Candidates included in the rank list can register their options online through the website www.cee.kerala.gov.in from 21.07.2025 to 27.07.2025, 11.59 PM. Candidate may enter their Application Number & Password in the link 'Integrated Five Year LL.B 2025 - Candidate Portal' provided in the above website to log on to their home page. Then by clicking the menu 'Option Registration' candidates can register their options online.

Candidates whose results are withheld due to defect in application can also register online options, but if relevant documents are not uploaded by such candidates within 25.07.2025, 3.00 PM their options will not be considered for the allotment process.

## **Option Registration Fee:**

Those candidates who wish to register options will have to remit registration fees of Rs.1000/- (Rupees One Thousand only) to the Commissioner for Entrance Examinations. Candidates belonging to SC/ST/OEC category eligible for benefits as per G.O (Ms) No. 25/2005/SCSTDD, dated: 20.06.2005 and G.O (Ms) No.10/2014/BCDD, dated: 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sreechithra Home will have to remit Rs.500/- (Rupees Five Hundred Only) as Registration Fee. Registration fess can be remitted by way of online payment. The registration fee of those candidates who do not get allotment will be refunded. If a candidate gets allotment and does not join within the stipulated time, the option registration fee will be considered as penalty and will not be refunded. Option registration fee of the candidates who quit the seats after taking admission will be considered as penalty and will not be refunded. Refund of option registration fee for

the eligible candidates will be made only after the completion of allotment process and it will be notified.

Candidates who fail to register their options online within the stipulated time will not be considered for allotment under any circumstances. Options forwarded to the Commissioner for Entrance Examinations by Email/Post/Hand delivery will not be processed or considered on any account for the allotment of seats.

# Documents to be produced at the time of admission

- 1. Candidate's Data Sheet.
- 2. Allotment memo issued by the Commissioner for Entrance Examinations.
- 3. SSLC or any relevant school records/birth certificate/passport/other valid document to prove date of birth in original.
- 4. Original Mark list and Pass Certificate of the qualifying examination.
- 5. Transfer Certificate and Conduct Certificate from the institution where the Candidate studied last.
- 6. Four copies of recent passport size photograph.
- 7. The applicant who is employed or trainee in Government/Quasi Government/Banks etc. shall, at the time of interview, produce a relieving order and a certificate of good conduct from the Head of the Institution where the candidate was employed.
- 8. Candidate who passed their qualifying examination from Universities/Boards

outside the state shall produce an "Eligibility Certificate" from the University concerned in Kerala, to the effect that the qualifying examination has been recognized by the University. The students opting for Law Colleges under various Universities in Kerala should have obtained the Eligibility Certificate from the University concerned sufficiently before the submission of online options for allotment under Centralised Allotment Process (CAP).

- 9. The student who qualifies from other Universities should produce migration certificate at the time of admission or before the commencement of first semester examination.
- 10. Originals of all the uploaded documents/certificates (to prove nativity /reservation/fee concession).
- 11. Self-declaration stating candidates's Nationality (Annexure XX)
- 12. Any other certificates/documents required to be furnished as per the prospectus/notifications/allotment memo.
