

## Admission to Integrated Five Year LL.B courses 2025

### Pre-requisites for applying online Application

#### Prospectus

Download and read the prospectus for admission to Integrated Five Year LL.B Course 2025 before applying for the course.

#### Computer System

The computer system used for applying online should have the following facilities:

**Internet** : Should have an internet connection.

**Browser** : Should have a browser. Recommended browsers are latest version of Mozilla Firefox and Google Chrome.

**PDF Reader** : Should have a PDF reader like Adobe PDF reader or Foxit Reader.

#### Email ID and Mobile Number

Candidate should provide their own mobile number or parent's mobile number at the time of online registration. All important communication regarding the Five Year LL.B Course 2025 will be sent to the registered Mobile Number. One mobile number cannot be used for more than one application. Candidate should also possess a valid email id. Keep this email id live and secure till the end of the admission process of Integrated Five Year LL.B Course 2025. If the candidate does not have an email id, a new email id must be created before applying online. Candidate should not provide the email id of others, under any circumstances. If forgot password (LLB 5 Year), it could be reset by accepting OTP in the registered mobile or in registered email address.

#### Certificates

The following documents and certificates are to be uploaded along with the application.

- Proof for Nationality as mentioned under clause 9(i).
- Proof for Nativity as mentioned under clause 9(i).
- Certificate to prove age: Relevant page of SSLC/Birth Certificate/Passport
- Non-Creamy Layer Certificate (for state education purpose) from the Village Officer in the case of SEBC/OEC candidates.(Annexure XI) (if applicable)
- Community Certificate from the Village Officer in the case of OEC candidates who do not come under Non-Creamy layer category.(Annexure XV) (if applicable)
- Non-Creamy Layer/Community and Income Certificates from the Village officer in the case of candidates belonging to the communities listed in Annexure IV (b). (If applicable)
- Certificates obtained from Tahsildar in the case of SC/ST candidates, also refer Clause 12c (iii) , Annexure XII. (if applicable)
- Inter-Caste marriage certificate: Candidates who are children of Inter-Caste married couple of whom one is SC/ST, need to upload **Inter-Caste marriage Certificate** issued by Tahsildar Clause 12c (i). (if applicable)

- The candidates eligible for EWS Quota seats should submit the EWS Certificate from the Village Officer in the prescribed format annexure IXa, IXb of Integrated 5 LLB Prospectus. (if applicable)
- Certificate in support of special reservation, if any, in the prescribed format, clause 11.(if applicable)
- Certificate from the District Medical Board for Persons with Disabilities, clause 12(e). (if applicable)
- Certificate from the Fisheries Officer concerned of Kerala Fishermen Welfare Fund Board for fee concession in the case of candidates who are the children of registered Fishermen.(Annexure XIV) (if applicable)
- Certificate from the Director, Department of Women & Child Development or from authorities concerned for fee concession in case of candidates who are inmates of Sri Chithra Home, Nirbhaya Home, Juvenile Home or any other such institution run by the Government

The uploaded document should be in PDF format.

The file size must be less than 500 KB.

The uploaded document should be correct, complete and readable.

#### **Application Fee**

Candidate should pay the application fee in any one of the following mode:

- Online Payment using Debit Card / Credit Card / Internet banking.
