**ADMISSION TO LLM COURSE 2022**  
**SECOND PHASE ALLOTMENT PUBLISHED**

The Second Phase of Centralized Allotment (CAP) for admission to the LLM Course in 4 Government Law Colleges and Private Self-financing Law Colleges that have entered into seat sharing agreements with the State for the year 2022-23 is published on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

Allotment has been finalized after addressing valid complaints on the provisional allotment list published on **18.01.2023**.

Candidates can access their homepage by entering their application number, and password in the '**LLM 2022-Candidate Portal**' provided on the website. Then, by clicking the menu item '**Allotment Result**' candidates can download their allotment memo. The details, such as candidate's name, roll number, allotment details, tuition fees etc. are available in the allotment memo. The candidate shall take a print out of the allotment memo. Candidates can log into their Home Page and then click the Menu Item '**Data Sheet**' to download the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges on any date from **20.01.2023** to **23.01.2023, 3.00 PM** along with the allotment memo and original documents specified in Clause 18 of the Prospectus. They should remit the complete fees as per the Government orders to the allotted college at the time of admission. Candidates will be liable to pay at the revised rate as and when the fee for the academic year 2022-23 in the Government Law colleges is revised by the Government. All the College Principals should approve and submit the list of admitted candidates through the Online Admission Management System (OAMS) on **23.01.2023.4.00 PM**.

Candidates belonging to SC/ST/OEC/Communities eligible for

Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

The candidates who do not join the college on the specified dates, will lose their present allotment and also the higher order options. Their existing options will not be considered for further allotments, if any. The details regarding further allotments, if any, will be notified later.

**Note:**

Allotment/Admission of candidates whose writ petitions are pending disposal in the Hon'ble High Court of Kerala is provisional in this phase and will be finalized on receipt of respective court orders/certificates as proof of their qualifications.
