NOTIFICATION LLM COURSES 2022 MOP UP ALLOTMENT - FRESH OPTIONS INVITED

The activities related to the Mop Up phase of allotment to fill up the vacant seats that exist/arise after the second phase of centralized allotment for admission to LLM Courses in the Government Law Colleges and Private Self-financing Law Colleges for the year 2022-23 commenced on 14.02.2023. Candidates who have figured in the rank list of the LLM Course 2022 published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per clause 6 in the prospectus can register fresh options and participate in this phase of allotment.

The schedule for the allotment is given below

14.02.2023	Website opens for fresh option registration
16.02.2023	Time for Option registration ends
17.02.2023	Publication of provisional Online Allotment
18.02.2023	Publication of final allotment
20.02.2023-22.02.2023	Time for joining at the allotted law colleges.

The candidates who get allotment in this phase shall have to join the allotted college with all original certificates as specified in prospectus clause 18 within the stipulated time and should remit the applicable tuition fee, other fees and deposits (if applicable) to the allotted colleges at the time of admission.

General Rules of Mop-up Allotment:

- 1. If no seat is allotted to the candidate in the mop-up allotment, the existing admission, if any, shall prevail, and, if a seat is allotted to the candidate in the mop-up allotment, the existing admission, if any, will stand cancelled and the candidate shall have to accept the new allotment.
- 2. Probable vacancies due to up-gradations to higher options or category conversions will also be filled up in the Mop-up allotment based on the options for the mop-up allotment hence, candidates are advised to take into account probable vacancies in addition to the real vacancies available at the start of the mop-up phase of the allotment process.
- 3. The seats received through Mop up allotment cannot be changed further at any instance.
- 4. Candidates who are allotted a seat in the mop-up allotment (irrespective of their admission status) will not be eligible for any subsequent allotments. Candidates who continue to be in admission status till the publication of the mop up allotment shall not be eligible to participate in further allotments.
- 5.After the Mop Up Allotment, if vacancies exist/arise, these vacancies shall be filled through the Stray Vacancy Filling Allotment. For this round, options registered by candidates during the Mop Up Round will be considered. Provision for fresh option registration will not be in Stray Vacancy Filling Allotment. A notification regarding the same will be issued later.
- 6.Candidates already admitted to the course through previous phases of allotment by the Commissioner for Entrance Examinations, if they get an allotment through the Mop up allotment, current admission to the course will stand cancelled. Hence candidates should register options to only those colleges where they want to study for the course if they get an allotment.

Those candidates who want to register options for Govt. Law Colleges

or Self Financing Law colleges for the mop-up allotment phase shall have to

pay an amount of Rs.3780/-(amount fixed as Annual Tuition Fee in Govt

Law Colleges) as registration fee to the Commissioner for Entrance

Examinations. Candidates who pay Rs. 3780/- can participate in the mop-up

phase in both government and self-financing law colleges. SC/ST/OE and

other candidates eligible for fee concession are exempt from paying the

registration fee.

The registration fee of candidates, who do not get any allotment in

the mop -up phase will be refunded, and the registration fee of those

candidates who do not join the course if allotted through the mop up phase

will be treated as penalty and will not be refunded. Candidates admitted to

the course through previous phases of allotment by the Commissioner for

Entrance Examinations can avail free exit from the course till the last date of

option registration to Mop Up Allotment. Candidates shall be liable for

penalty if they vacate seats or obtain T.C after the last date of option

registration for Mop Up Allotment.

Candidates who receive allotment should have attained eligibility for

admission as per Clause 6 of the Prospectus at the time of admission.
