**ADMISSION TO LLM COURSE 2023**  
**SECOND PHASE ALLOTMENT PUBLISHED**

The Second Phase of Centralized Allotment (CAP) for admission to LLM Course in 4 Government Law Colleges and Private Self-financing Law Colleges of the State which have entered into seat sharing agreement with the Government for the year 2023-24 is published in the website **www.cee.kerala.gov.in**.

Allotment has been finalized after addressing complaints on provisional allotment list which was published on **18.11.2023**.

Candidates can access their homepage by entering their application number, and password in the '**LLM 2023-Candidate Portal**' provided in the website. Then by clicking the menu '**Allotment Result**' candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc. are available in the allotment memo and the candidate shall take a print out of the allotment memo. Candidates can download the Data Sheet from the Menu '**Data Sheet**'.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges on any date from **21.11.2023 to 24.11.2023, 3.00 PM** along with the allotment memo and original documents specified in Clause 18 of the Prospectus. They should remit the complete fees as per Government orders in the allotted college at the time of admission. Candidates will be liable to pay at the revised rate as and when the fee for the academic year 2023-24 in the Government Law colleges are revised by the Government. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **24.11.2023, 4.00 PM**.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

The candidates, who do not join the college on the specified dates, will lose their present allotment and also the higher order options. Their existing options will not be considered for further allotments, if any. The details regarding further allotments, if any, will be notified later.

**Note:**

Allotment/Admission of candidates whose writ petitions are pending disposal in the Hon'ble High Court of Kerala is provisional in this phase and will be finalized on receipt of respective court orders.
