## ADMISSION TO LLM COURSE-2024 FIRST PHASE CENTRALIZED ALLOTMENT PUBLISHED

The First Phase Centralized Allotment (CAP) for admission to LLM Course in Government Law Colleges and Private Self-financing Law Colleges which have entered into seat sharing agreement with the State Government for the year 2024-25 is published in the website **www.cee.kerala.gov.in**. Candidates will be liable to pay the fees at the revised rate as and when the fee for the academic year 2024-25 in the Government Law colleges are revised by the Government.
