ADMISSION TO PG MEDICAL/PG DENTAL AND
DNB (POST MBBS) COURSES 2022
SPECIAL STRAY VACANCY FILLING

The Medical Counselling Committee (MCC) vide Notice dated 03.01.2023 has decided to conduct a Special Stray Vacancy Round for the vacant seats in MD/MS/Diploma/PG DNB for the academic year 2022-23 for All India Quota Seats. In line with the Special Stray Vacancy Round conducted by the Medical Counselling Committee (MCC), the Commissioner for Entrance Examinations has also decided to conduct a Special Stray Vacancy Round for the PG Medical/PG Dental/DNB (POST MBBS) including Service Quota seats lying vacant after the Stray Vacancy filling and Service Quota Allotment in Govt. & Self Financing Medical/Dental colleges, as the case may be. These vacancies will be filled at the respective colleges based on the lists forwarded and the guidelines issued by the Commissioner for Entrance Examinations.

In Special Stray Vacancy round fresh option registration facility is available to eligible candidates. Those candidates who are currently holding PG Medical/PG Dental/DNB (Post MBBS) seats through All India Quota/State Quota counseling and those candidates who are allotted/admitted to PG Medical/PG Dental/DNB (Post MBBS) courses through mop up/stray vacancy allotment will be excluded from the Special Stray Vacancy Allotment. Candidates included in the 'Ineligible Candidate List' are also not permitted to participate. The net vacant seats are published in the website of the Commissioner for Entrance Examinations. Any unavailed seats that may be available during the allotment will also be converted in this round. The facility for fresh registration will be available on the website of Commissioner for Entrance Examinations from **06.01.2023 to 09.01.2023, 10.00 AM.**

- Registration fee amounting to the annual tuition fee shall be paid if opted only Government PG Medical seat. Registration fee of Rs.2,00,000 (Rupees Two Lakhs

only) shall be paid if opted for a seat in Private Self financing Medical College also. Registration fee for PG Dental Course is Rs.1,00,000 (Rupees One Lakhs only). For SC/ST/OE and other candidates who are eligible for fee concession, the registration fee for Govt. /Pvt. Medical college seats will be half of the above amounts respectively.

- The registration fee of those candidates who have already paid the registration fee for the mop up round allotment to PG Medical/PG Dental courses and did not get any allotment will be considered as the stray vacancy registration fee. If the registration fee paid to the Commissioner for Entrance Examinations is less than the stray vacancy registration fee, they will have to pay the balance registration fee.
- The registration fee applicable to a candidate will be fixed as per the details entered by the candidate in the stray vacancy registration page available on the Candidate Portal in the website www.cee.kerala.gov.in. Candidates can register options to stray vacancy allotment only after paying the applicable Registration fee to Commissioner for Entrance Examinations. The Registration fee once paid will not be changed at any instance. Thus candidates should be very careful, while giving conditions to fix the Registration fee.
- The registration fee of those candidates, who get an allotment through stray vacancy allotment will be carried over to Tuition Fee of course allotted and the registration fee of those candidates who will not get any allotment will be refunded after the closing of admission to PG Medical/PG Dental Course.
- The registration fee paid for the stray vacancy round by those candidates who do not join the seat allotted in stray vacancy filling allotment will be treated as penalty and will not be refunded.

The schedule is as given below:

06.01.2023	Website open for enabling Online Option registration
09.01.2023,10.00 AM	Facility for Online registration of options ends.
10.01.2023	Publication of Allotment & Eligible lists.
11.01.2023 to 13.01.2023, 2.00 PM	Reporting period of the candidates.
14.01.2023, 2.00 PM	College authorities shall have to submit the list of admitted candidates to the CEE through the Online Admission Management System (OAMS)

Three Lists have been issued for this phase of Stray Vacancy filling round of admission.

List 1, Allotment List: List has been prepared based on options registered by the candidates and the vacancies available in this special stray vacancy filling round .

List 2, Probable List: List has been prepared based on options registered by the candidates in this special stray vacancy filling round.

List 3, Eligible Candidate List: Includes those candidates who are eligible to be considered for admission.

Candidates shall be considered from these lists based on the priority levels. Candidates can check the Lists and guidelines that have been published on the official website of the Commissioner for Entrance Examinations. Candidates included in the Lists, may contact the college authorities concerned and participate in the allotment process before **13.01.2023, 2.00 PM**. Candidates should submit the required documents, and shall remit the entire fee at the time of admission before **13.01.2023, 4.00PM**.

If any candidate vacates a seat joined in Stray Vacancy Allotment or vacates a joined seat (joined in any of the previous round also) after stray vacancy allotment process he/she will be liable to pay liquidated damages amounting to Rs.50,00,000 (Rupees Fifty lakhs) for PG Medical course and Rs.20,00,000 (Rupees Twenty Lakhs) for PG Dental course to the CEE and will be liable for revenue recovery if not paid. A candidate who does not pay the liquidated damages will be debarred from appearing for the allotment/admission process to PG Medical course for a period extending upto two consecutive years.

Guidelines for Stray Vacancy filling round allotment have been published in the official website of the Commissioner for Entrance examinations.
