### **SECOND PHASE ALLOTMENT TO**

# POST GRADUATE DENTAL (DEGREE ) COURSES, KERALA – 2023 FACILITY FOR ONLINE OPTION CONFIRMATION/ DELETION/REARRANGEMENT AVAILABLE

The activities related to the second phase of Centralized allotment to Post Graduate Dental Degree Courses for the year 2023 in the State commences from **01.09.2023**. The vacant seats under State quota seats after the first round of counseling in Government Dental Colleges and Self-financing Dental Colleges shall be filled up in this phase of allotment.

Candidates included in the state rank list published by the Commissioner for Entrance Examinations can log on to the website www.cee.kerala.gov.in and then click the link 'PG Dental 2023 - Candidate Portal' to access their home page. Candidates can then rearrange/delete their existing higher order options if needed, after clicking the 'Confirm' button available therein. Candidates who have not received any allotment in the first phase can also re-arrange/delete their existing options. The facility for online option confirmation/deletion/re-arrangement shall be available in the above website from 01.09.2023 to 04.09.2023,10.00 AM.

## **Online Option Confirmation is mandatory**

In the Second Round Counselling, their is no facility for fresh option registration for the candidates. Only option confirmation/deletion/re-arrangement of the existing options in Round 2 is possible. Option confirmation is compulsory to participate in Round 2. Option registration will be available only if any new course is added to the list at this stage. If a candidate is allotted a seat in the first round and joined the allotted seat, his/her higher options will be retained and all those options listed below the allotted options will automatically be deleted thus enabling only upgradation/retention in the same seat. If a candidate joined in a seat in Round 1 does not give confirmation of option in the Round 2 he will not be

considered for upgradation in Round 2, but the seat joined in Round 1 will be retained. So, if a candidate joined in Round 1 does not want upgradation in Round 2, he/she may not confirm options or delete all options registered.

<u>Free Exit Conditions</u>: Those candidates who wish to vacate the seats joined through Round 1 can exit the seat on or before the last date and time fixed for option confirmation, that is, **04.09.2023**, **10.00** AM. But such candidates will not be considered for further rounds of centralised allotment processes except in Stray Vacancy Allotment.

**Service Quota Candidates:** The rank list of Service Quota candidates has been published in the website www.cee.kerala.gov.in. The candidates included in the Service Quota Rank List can register their options for admission to PG Dental Course 2023 in this phase.

Those candidates who have received or not received any allotment in the first phase, and want to be considered for the second phase of allotment shall have to confirm their options online by clicking the 'Confirm' button available in the Home page of the candidate. Those who do not Confirm their options online will not be considered for the second phase of allotment for the existing options.

Candidates allotted to courses, should take admission in the college/course allotted after remitting the fee/balance fee as per the schedule prescribed by the CEE. No extension of time for reporting to the college will be granted under any circumstances. The candidates are liable to pay admission fee as prescribed by the University concerned at the time of admission.

**Note:** Candidates who belong to SC/ST/OEC/Children of Fisherman/Inmates of Sri Chithra home, Nirbhaya home, Juvenile home are exempted from payment of fees.

The allotment to Colleges/Courses will be subject to recognition of All India Regulatory Bodies/Affiliation from the Universities concerned.
