PG DENTAL (DEGREE) COURSE, KERALA-2023
THIRD ROUND ALLOTMENT - FACILITY FOR ONLINE OPTION
REGISTRATION FOR NEWLY APPLIED CANDIDATES

Candidates who have applied afresh for admission to PG Dental Course due to lowering of minimum qualifying percentile vide this office Notification dated 23.09.2023, can register options for considering them in the third phase allotment.

All the newly registered Candidates can register their options for admission to PG Dental Courses 2023 in the State through the Website www.cee.kerala.gov.in from **30.09.2023 to 03.10.2023, 5.00PM**. However, those eligible candidates who are included in the Kerala State Merit List will only be considered for allotment. The State Merit List will be published after finalizing the category of the applicants.

Candidate shall have to click '**PG Dental 2023-Candidate Portal**' available in the above website and enter their Application Number and Password in order to access their home page. The Candidates can register their options online by clicking the menu '**Option Registration**' available in the home page.

A security deposit of Rs. 10,000/- will have to be paid at the time of option registration. For SC/ST/OEC and other candidates who are eligible for fee concession, Rs.5000/- will have to be paid as security deposit. Those candidates who got an allotment and took admission in the first phase, the security deposit will be adjusted to the tuition fee to be paid at the College or if the candidate does not get an allotment in this or subsequent phases, the security deposit will be refunded after the completion of the entire counseling process.

The schedule for the allotment is given below:

30.09.2023	Opening of the option registration facility.
03.10.2023 5.00 PM	Closing of option registration facility.

The list of Dental Colleges/Courses to which the Commissioner for Entrance Examinations makes allotment is provided in the Home page of the candidate. Candidates can give options as per their priority of the Course/College combinations in the option list. **A candidate need only to give options to a Course-College combination if he/she is sure to join the course and college, under the chosen quota, if allotted.** Options registered online alone will be considered for allotment to the courses. Options sent to the Office of the Commissioner for Entrance Examinations via Post/Fax/E-mail will not be processed/ considered for allotment to the courses.

Candidates who seek admission under Minority/NRI quota in Self Financing Dental Colleges shall have to register options online to the desired courses/colleges. Candidates who do not register options shall not be considered for allotment under Minority/NRI quota even if they are included in the respective category lists.

Candidates are required to go through the Notification dated 17.09.2023 and provisions in the Prospectus before registering options. All details related to the allotment process are available on the website **www.cee.kerala.gov.in**. Candidates are also required to visit the above website regularly for Notifications and announcement regarding allotment.
