ADMISSION TO PG DENTAL COURSES-2025 THIRD PHASE FINAL ALLOTMENT LIST PUBLISHED

The Third Phase Allotment to the PG Dental (MDS) courses 2025 to the Government Dental Colleges and Private Self Financing Dental colleges in the State is published in the website www.cee.kerala.gov.in.

To view the Allotment Result, candidates should log on to the 'PG Dental 2025-CandidatePortal' by submitting their Application Number and Password. By clicking on the link 'Allotment Result', candidates can view their Allotment Result. It is necessary to take the printout of the Allotment Memo. The allotted candidates should report for joining at the allotted colleges from 17.08.2025 to 20.08.2025, 4.00 PM, along with all required documents specified in the Allotment Memo as per Prospectus clause 18.2.

This is the **Final Phase Centralized Allotment Process (CAP)** to MDS conducted by the Commissioner for Entrance Examinations for the academic year 2025-26. Course once allotted in the Third Phase Allotment shall be final. Surrender of seats after this Allotment will not be permitted. The registration fee of those candidates who **do not join the seat allotted** through the Third Round will be treated as penalty and will not be refunded. As per **clause 19.5.1**, if a Post Graduate student including (SC/ST/OEC & BPL Category) discontinues the PG Dental Course after the Final Centralized Allotment Process (CAP) he/she shall pay **Rs. 20,00,000/(Rupees Twenty Lakh only)** as Liquidated Damages and also refund the stipend/salary already received. If a service candidate discontinues the PG Dental Course after the stray vacancy allotment, he/she shall pay Liquidated Damages as stipulated in **clause 11.5.** Those candidates who vacate their seats admitted through **previous allotments** conducted by Commissioner for

Entrance Examinations after the third phase allotment will also be liable to pay the liquidated damages as mentioned above.

In case vacancies exist/new vacancies arise after this Allotment, these vacancies will also be filled in through **Stray Vacancy Filling Round.** Fresh option registration facility for stray vacancy filling round will be notified later. Candidates are required to go through the notification dated **06.08.2025** for more information regarding stray vacancy filling allotment.
