SECOND PHASE OF ALLOTMENT TO PG PHARMACY (M.PHARM) COURSES 2021
FACILITY FOR ONLINE OPTION CONFIRMATION

The activities related to the second phase of centralized allotment to PG Pharmacy Courses for the year 2021 will commence from 22.10.2022. Candidates who have already got allotment in various Pharmacy Colleges and those who have no allotment through the first phase of allotment can confirm online options to be considered for second phase of online allotment.

Online Option Confirmation is mandatory

The Candidates who want their higher order options in PG Pharmacy courses to be considered shall have to log into their Home Page available in the link '**M.Pharm-2021 Candidate Portal**' and confirm their options by clicking the **option confirmation** button available therein. After **Online Option Confirmation**, candidates can re-arrange their higher order options or delete the unwanted options from **22.10.2022 to 25.10.2022, 03.00 pm**, through the website **www.cee.kerala.gov.in**. Online option confirmation is mandatory for those who have got admission and those who have no allotment as per the prior allotment conducted by Commissioner for Entrance Examinations to consider them in this phase of allotment. But for those who do not confirm their options, the admission in the previous phase shall be retained.

On the basis of options received up to **25.10.2022, 03.00 pm**, the allotment will be published in the website **www.cee.kerala.gov.in** on **28.10.2022**. Candidates who receive allotment in this phase shall have to take a printout of their allotment memo and remit the fee at the concerned college allotted from **30.10.2022 to 02.11.2022** and join the course/college allotted before **4 pm on 02.11.2022**.

The schedule for the second phase of allotment is given below:

22.10.2022	Website opens for Online Option Confirmation and for enabling re-arrangement of higher options/deletion of unwanted options for PG Pharmacy course.
25.10.2022, 3.00 PM	Time for Online Option Confirmation and re-arrangement/ deletion of options ends.
28.10.2022	Publication of Allotment

31.10.2022 to 02.11.2022, 4.00 PM	Joining Time
02.11.2022, 5.00 PM	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) for PG Pharmacy course.

Candidates allotted to the courses/ college should remit the fee mentioned in the allotment slip at the college allotted and take admission as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not remit the prescribed fees/take admission within the stipulated time will lose their allotment. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home need not remit fees. Notification regarding Mop up counseling, if any, will be issued later.
