SECOND PHASE OF ALLOTMENT TO PG PHARMACY (M.PHARM) COURSE 2022 FACILITY FOR ONLINE OPTION CONFIRMATION

The activities related to the second phase of centralized allotment to PG Pharmacy Course for the year 2022 will commence from 22.11.2023. Candidates who have already got allotment in various Pharmacy Colleges and those who have no allotment through the first phase allotment can confirm online options to be considered for second phase of online allotment.

Online Option Confirmation is mandatory

The Candidates who want their higher order options in PG Pharmacy course to be considered for second phase allotment shall have to log into their Home Page available in the link 'M.Pharm-2022 Candidate Portal' and confirm their options by clicking the "option confirmation". After Online Option Confirmation, candidates can re-arrange their higher order options or delete the unwanted options from 22.11.2023 to 24.11.2023, 3.00 PM, through the website www.cee.kerala.gov.in. Online option confirmation is mandatory for those who have got admission and those who have no allotment as per the prior allotment conducted by Commissioner for Entrance Examinations to consider them in the second phase of allotment. But for those who do not confirm their options, the admission in the previous phase shall be retained.

On the basis of options received up to 24.11.2023, 3.00 PM, the allotment will be published in the website www.cee.kerala.gov.in on 25.11.2023. Candidates who receive allotment in this phase shall have to take a printout of their allotment memo and remit the fee at the allotted college from 28.11.2023 to 30.11.2023 and join the allotted course/college before 4.00 PM on 30.11.2023.

Candidates allotted to the courses/college should remit the fee mentioned in the allotment slip at the college allotted and take admission as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not remit the prescribed fees/take admission within the stipulated time will lose their allotment. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home need not remit fees. Notification regarding Mop up counselling as per clause 12.9 of the prospectus, if any, will be issued later.
