PG PHARMACY (M.PHARM) COURSE 2024
MOP UP ALLOTMENT
FACILITY FOR OPTION REGISTRATION ENABLED

The online Mop-up counseling for allotment to PG Pharmacy courses-2024 has commenced. All eligible Candidates who are included in the M.Pharm 2024 state rank list can register online options for Mop up phase of online allotment, irrespective of admission status.

Online Option Registration is mandatory

The Candidates who want to be considered for the Mop Up allotment shall have to log into their Home Page available at the link '**M.Pharm-2024 Candidate Portal**' and access the option registration portal by clicking the "**Option registration**" link. The candidates can register options from **12.12.2024 to 15.12.2024, 05:00 PM**, through the website **www.cee.kerala.gov.in**. Options registered in the previous phases will not be considered and, therefore, options must be registered afresh in order to be considered for allotment in this phase. The options registered by the candidates will be considered for seat allotment in accordance with the various provisions under clause 12 of the prospectus.

On the basis of options received up to **15.12.2024, 05:00 PM**, the provisional allotment will be published in the website **www.cee.kerala.gov.in** on **17.12.2024**. Candidates who receive an allotment in this phase shall have to take a printout of their allotment memo and remit the fee at the allotted college from **19.12.2024 to 21.12.2024** and join the allotted course/college before **4:00 PM on 21.12.2024**.

The schedule for the Mop Up allotment is given below:

17.12.2024	Publication of Provisional Allotment
18.12.2024	Publication of Final Allotment
19.12.2024 to 21.12.2024, 04.00 PM	Joining Time
21.12.2024,05.00 PM	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) for PG Pharmacy course.

Candidates allotted to the courses/college should remit the fee mentioned in the allotment slip at the college allotted and take admission as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not remit the prescribed fees/take admission within the stipulated time will lose their allotment. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home need not remit fees.
