**NOTIFICATION**

**ALLOTMENT TO PG AYURVEDA DIPLOMA COURSES AND**  
**MOP-UP ALLOTMENT TO P G AYURVEDA DEGREE COURSES -2021**  
**CANDIDATES CAN REGISTER FRESH OPTIONS**

The activities related to the Allotment for admission to PG Ayurveda Diploma Courses and Mop-up allotment to PG Degree courses in the Government/Aided/Self-financing Ayurveda colleges for the year 2021-22 commenced on 04.03.2022. Following candidates are eligible for submitting options:

1. Candidates included in the Kerala State Merit List (published on 03.02.2022) for allotment to Post Graduate Ayurveda Degree Courses can submit fresh online options to be considered for allotment to vacant Degree seats existing after the second phase allotment.
2. Candidates (Keralites only) included in the Kerala State Merit List (published on 02.03.2022) for allotment to Post Graduate Ayurveda Diploma can submit fresh online options to be considered for allotment to Diploma seats. Candidates included in this rank list (Keralite and Non-Keralite) can register fresh options to be considered for 15% All India Merit PG Ayurveda Degree seats also.

Those candidates who are blocked from further participation in state quota allotments on account of being admitted in AIQ seat or allotted a seat in the third (Mop-up) round of the All India Counseling will not be considered in this and subsequent phases of the state CAP.

Candidates who have obtained admission in Kerala Government merit seats for an Ayurveda course in any of the Government Ayurveda Colleges shall not be eligible to participate in the Mop-up Counselling for the same speciality in other Government Ayurveda Colleges. Similarly, Candidates who have obtained admission in Kerala Government merit seats for an Ayurveda course in any of the Self-financing Ayurveda Colleges shall not be eligible to participate in the Mop-up Counselling for the same speciality in other Self-financing Ayurveda Colleges. However a candidate who got admission in Government merit seats of a Self-financing Ayurveda College shall be permitted to take admission in the same/other subject in a Government Ayurveda College through Mop-up Counselling.

During this phase, candidates are advised to choose and order their options according to the

following conditions.

1. The options registered by the candidates for this phase would be the basis for the subsequent Stray Vacancy Filling Allotments, if any. In that case, there will not be separate option registration or confirmation step prior to those allotments and the candidates will not be considered for Stray Vacancy Filling Allotment to those courses and colleges not chosen by them for the Mop-up Phase Allotment. So, failure to register options in this phase will make the candidate ineligible to get an allotment not only in this phase but in subsequent Stray Vacancy Filling Allotments also.
2. Any candidate who is allotted a seat in this phase or any subsequent Stray Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent allotments.
3. Candidates who have already been admitted in PG Ayurveda Course, will lose the existing admission if they get an Allotment in this phase.
4. If any candidate already holding a seat allotted in a previous phase wants to quit that seat, the candidate must get TC from the college concerned before the last date of Option Registration for this phase and get it reported by the college to the CEE on the same day. Candidates will not be allowed to leave the seat allotted to them at any phase, once the option registration of this (Mop-up) Phase ends, except the ones caused by an up gradation to a higher option during the allotment process of this (Mop-up) Phase.
5. Option registration is a mandatory step of this phase irrespective of whether options were registered or not registered in the previous phases. The options have to be registered through the Online Option Registration facility accessible after logging on to the Candidate portal on the website, [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) by giving their Application Number & Password through the link “PG Ayurveda- 2021 Candidate Portal” Then by clicking the Menu item ‘Option Registration’, candidates can register their options online within the stipulated time.
6. Candidates can register options to any of the courses existing in any of the colleges which the candidate wishes to join irrespective of the existing vacancy position as the seats being vacated as part of the allotment process when candidates already holding a seat allotted to them in a previous phase are re-allotted to a higher option, will also be filled as part of the same allotment process itself. Those candidates who have not registered their options within the stipulated time will not be considered for the allotments in this phase and subsequent stray vacancy filling allotments.

**The schedule for allotment/Mop-up allotment is given below**

<b>04.03.2022</b>	Website opens for Option Registration
<b>08.03.2022, 10 AM</b>	Time for Option Registration ends
<b>10.03.2022</b>	Publication of Allotments.
<b>11.03.2022-15.03.2022 2 PM</b>	Date for joining the allotted college
<b>15.03.2022, 3 PM</b>	College authorities should approve and submit the list of admitted candidates through OAMS

Candidates who receive allotment should have attained the eligibility for admission as per clause 5 of the prospectus for PG Degree/Diploma courses at the time of admission.

**Note: The vacancies, if any, remaining in Ayurveda Diploma /Degree Courses in Ayurveda Colleges after 3 PM on 15.03.2022 shall be filled up through Stray Vacancy Filling Allotments, the details of which will be notified later.**
