NOTIFICATION ADMISSION TO PG AYURVEDA COURSES-2022 MOP- UP ALLOTMENT Facility for Option Registration Enabled

The Mop-up counselling phase for allotment to PG Ayurveda Courses 2022 commenced on 03.03.2023. In this round fresh option registration facility is available to candidates.

The schedule for the Mop-up phase is as given below:

03.03.2023	Website opens for Online Option registration afresh.
06.03.2023, 4.00 PM	Facility for Online option registration ends.
08.03.2023	Publication of provisional Mop- up phase allotment.
09.03.2023	Publication final Mop-up Allotment.
10.03.2023- 13.03.2023, 3.00PM	Joining at the allotted colleges.
13.03.2023, 4.00PM	Submit the list of admitted candidates to the CEE by the colleges through the Online Admission Management System (OAMS)

Those candidates who are blocked from further participation in state quota

allotments on account of being admitted to an AIQ seat will not be considered in this and subsequent phases of the state admission procedures and candidates allotted a seat in the third (Mop-up) round of the All India Counseling will also be ineligible to participate in this and subsequent phases of the state allotments.

Candidates who have obtained admission in Kerala Government merit seats for an Ayurveda course in any of the Government Ayurveda Colleges shall not be eligible to participate in the Mop-up Counselling for the same speciality in other Government Ayurveda Colleges. Similarly, Candidates who have obtained admission in Kerala Government merit seats for an Ayurveda course in any of the Self-financing Ayurveda Colleges shall not be eligible to participate in the Mop-up Counselling for the same speciality in other Self-financing Ayurveda Colleges. However a candidate who got admission in Government merit seats of a Self-financing Ayurveda College shall be permitted to take admission in the same/other subject in a Government Ayurveda College through Mop-up Counselling.

Option registration is a mandatory step of this phase irrespective of whether options were registered or not in the previous phases. The options have to be registered through the Online Option Registration facility accessible after logging on to the Candidate portal on the website, www.cee.kerala.gov.in by giving their Application Number & Password through the link "PG Ayurveda- 2022 Candidate Portal". Then by clicking the Menu item 'Option Registration', candidates can register their options online within the stipulated time.

During this phase, candidates are advised to choose and order their options according to the following conditions.

1. The options registered by the candidates for this phase would be the basis for the subsequent Stray Vacancy Filling Allotments, if any. In that case, there will not be a separate option registration or confirmation step prior to those allotments and the candidates will not be considered for Stray Vacancy Filling Allotment to those courses and colleges not chosen by them for the Mop-up Phase Allotment. The options registered in this Mop-up phase will be considered for Stray vacancy seat filling also. So, failure to register options in this phase will make the candidate ineligible to get an allotment not only in this phase but in subsequent Stray Vacancy Filling Allotments also.

- 2. Any candidate who is allotted a seat in this phase or any subsequent Stray Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be considered for the subsequent allotments.
- 3. Candidates who have already been admitted to the PG Ayurveda Course, will lose their existing admission if they get an Allotment in this phase. Surrender of seats after Mop Up Allotment will not be permitted.
- 4. If any candidate already holding a seat allotted in a previous phase wants to quit that seat, the candidate must get TC from the college concerned before the last date of Option Registration for the Mop Up allotment phase (ie 2.00PM of 06.03.2023) and get it reported by the college to the CEE on the same day. Candidates will not be allowed to leave the seat allotted to them at any phase, once the option registration of this (Mop-up) Phase ends, except the ones caused by an upgradation to a higher option during the allotment process of this (Mop-up) Phase.
- 5. Candidates can register options (as per the conditions mentioned in the prospectus) to any of the courses existing in any of the colleges that the candidate wishes to join irrespective of the existing vacancy position as the seats being vacated as part of the allotment process when candidates already holding a seat allotted to them in a previous phase are re-allotted to a higher option, will also be filled as part of the same allotment process. While registering options, candidates are advised to take into account probable vacancies that may arise due to the applicable category conversion rules also.

Registration Fees

A separate Registration fee has been implemented for all candidates, to register fresh options in the Mop up Phase.

Those candidates who want to register options for Mop Up Allotment in Govt. and Self Financing Ayurveda Colleges shall have to pay an amount of Rs.16540/- (the amount fixed as the Annual Tuition Fee in GOVT colleges) as a registration fee to the Commissioner for Entrance Examinations. Candidates can participate in mop up rounds in both Govt. and Self Financing Ayurveda Colleges by paying the amount. For SC/ST/OE and other candidates eligible for fee concession, a registration fee of Rs.2000/- (Rs. Two Thousand Only) must be paid for registering options in Govt and Self Financing Colleges.

The registration fee paid for the Mop Up allotment will be adjusted in the fee of the course (if applicable) if the candidate gets an allotment .The registration fee of candidates, who do not get any allotment in the mop-up phase will be refunded.

The registration fee of those candidates who do not join the course if allotted through the mop up phase will be treated as penalty and will not be refunded. Candidates admitted to the course through previous phases of allotment by the CEE shall be liable for penalty equivalent to the registration fee, if they vacate seats or obtain T.C after the last date of option registration for Mop Up Allotment.
