## NOTIFICATION ADMISSION TO PG AYURVEDA COURSES, KERALA- 2022 MOP-UP ALLOTMENT PUBLISHED

The Mop-up Allotment to fill the vacant PG Degree seats in the Government/Aided/Self- financing Ayurveda Colleges for the year 2022-23 has been published. Candidates can view the allotment results on the website www.cee.kerala.gov.in. The allotment is based on the online options registered for mop up allotment within the stipulated time. The Mop-up Allotment has been published after addressing valid complaints received regarding the provisional mop-up allotment published on 08.03.2023.

Candidates can access their Home Page by entering their application number and password in the 'PG Ayurveda 2022- Candidate Portal' provided on the website. Then, by clicking the menu item 'Allotment Result', candidates can download their Allotment Memo. The details, such as candidate's name, roll number, allotment details, tuition fees etc. are available in the Allotment Memo.

All candidates who have received allotments should join the college allotted from 10.03.2023 to 13.03.2023, 3.00 PM. Printout of the Data Sheet, Allotment Memo and the documents as per clause 9.3 may also be produced before the college authorities at the time of admission.

Candidates shall pay fees at the allotted college as mentioned in the Allotment Memo. Candidates allotted under the SC/ST/OEC category and those having benefits as per G.O(MS) 25/2005/SCSTDD, dated 20.06.2005 and G.O (MS) 10/2014/BCDD, dated 23.05.2014 and those candidates from Sree Chithra Home, Juvenile Home, Nirbhaya Home and Children of Registered Fishermen as per G.O (MS)NO.47/14/FPD dated 09.06.2014 allotted against merit seats are exempted from remitting tuition fees.

Candidates who have got a change in college from the last allotment, should collect the TC, original documents and fee paid at the last allotted college and join the newly allotted college, failing which, they will lose their current admission also.

The conditions stipulated in the notification published on 03.03.2023 will be applicable for candidates participating in the mop up phase.

The registration fee of candidates who do not join the course through the mop up phase will be treated as penalty and will not be refunded. Candidates admitted to the course through previous phases of allotment by the CEE shall be liable for penalty equivalent to the registration fee, if they vacate seats or obtain T.C.

All the College Principals should approve and submit the list of admitted candidates through the Online Admission Management System (OAMS) at 4.00 PM on 13.03.2023.

If seats remain vacant after 3.00 PM on 13.03.2023 in PG Ayurveda Courses, they will be filled through stray vacancy allotments, the details in this regard will be published later.
